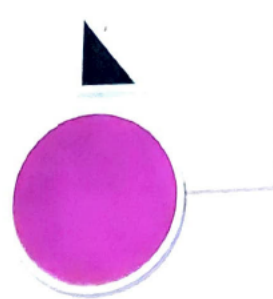

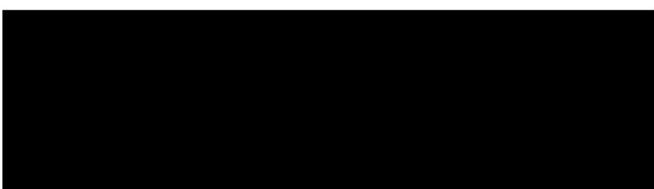
Auditor's Report 2024-2025

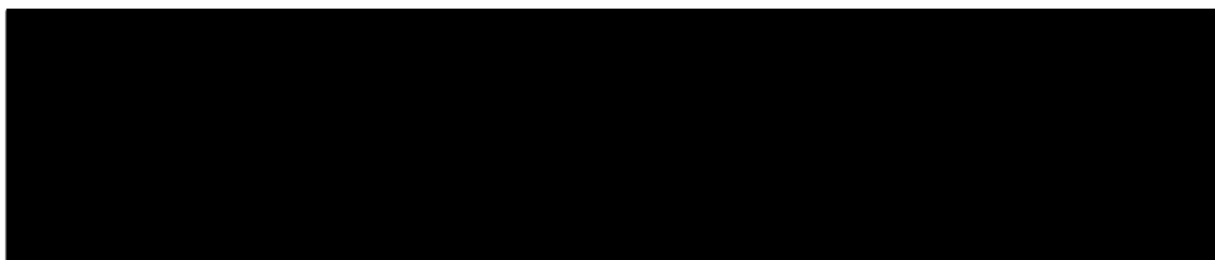
It is my opinion that the Treasurer's Report gives a full and accurate account of the orchestra's financial activities in session 2024-2025.
