Weekly church services are conducted and other events take place regularly such as lunch clubs, ladies meetings and such like. Other groups including charitable organisations, other church groups and those from the third sector make regular use of our premises as a venue for activities and for provision of meeting rooms. Swimming clubs and youth groups from remoter parts of the highlands regularly use the premises for accommodation as do several church youth camps. Talks are regularly given by charities and mission groups who we also help with funding.

Report of the Trustees for the year ended 31 December 2024

The Trustees are pleased to present their report together with the financial statements of the church for the year ended 31 December 2024.

Governing document

The charity is a merged congregation (incorporating Inverness and Dingwall congregations) of the Associated Presbyterian Churches of Scotland (SC002313) and uses the model constitution of that body-Deed of Separation from the Free Presbyterian Church of Scotland dated 27 May 1989, and resolution dated 30 May 1989.

Objectives and Activities

The church's objectives are to glorify God and to work for the advancement of Christ's kingdom within the local community and throughout the world.

Recruitment and appointment of trustees

The charity trustees are members of the Kirk Session (elders) and the Deacons' Court. The elders and deacons are elected by the members of the congregation from those members who are considered to have the appropriate gifts and skills. The minister of the congregation is an elder and deacon ex officio and acts as a Moderator of the Kirk Session and chairman of the Deacons' Court. All elders are also deacons.

Review of our Achievement and Performance

In 2024 the congregation continued its prayerful interest in practising Christian faith. This was shown in many ways including through caring for one another, visiting the sick, homebound, bereaved and infirm.

Almost every Sunday afternoon, members of the church provided short services of worship in local care homes. Lunch clubs with guest speakers were held once a month during school terms. In December, we hosted short talks with tea and coffee explaining the meaning of Christmas. The talks were entitled 'Why Jesus at Christmas?' and explained why it matters who Jesus is and why he came into the world.

Preaching during the year was based on Bible readings from both Old and New Testaments. These included series from the books of Galatians, Job, 1 Peter, and the Ten Commandments in Exodus 20. At the Wednesday evening Bible study and prayer meeting, teaching was based on the books of Numbers and James.

Various Christian works in the community were supported personally, in prayer and with financial contributions from mission offerings. The church hosted a successful launch evening for the Westside Youth Project and supports this valuable Christian work in the local community.

We thank the Lord God for his sustaining the church this year and enabling us to learn and grow in his word and providing opportunities to practice Christian faith including sharing the good news of Jesus Christ.

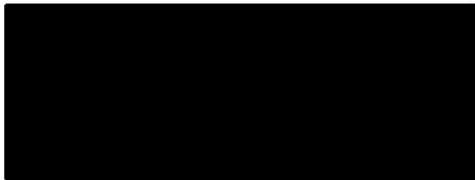

Financial Review and Reserves Policy

The church's principal source of income is weekly offerings, augmented by gift aid tax repayments where appropriate. There was a deficit for the year of £18,319 (2023: surplus £10,610). At the year-end there were total funds of £77,522 (2023: £95,841), the trustees believe that they will be able to meet expenses as they arise.

Report of the Independent Examiner for the year ended 31 December 2024

I report on the accounts of the charity for the year ended 31 December 2024 which are set out on pages 5 to 10.

Respective responsibilities of trustees and examiner

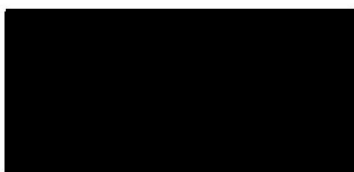
Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given in the accounts.

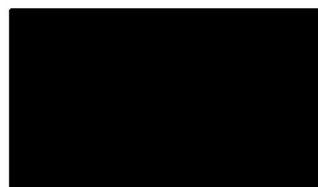
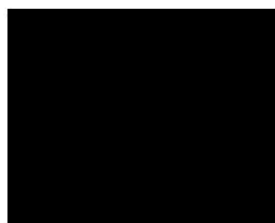

Funds Structure

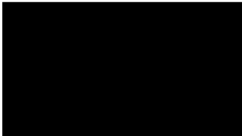
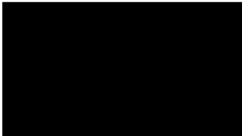
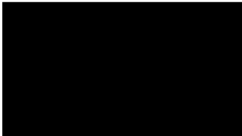
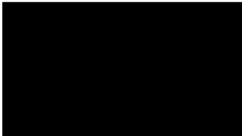
For the purpose of the Statement of Financial Activities as shown on page 5, funds are defined as follows:

- *Designated funds* represent unrestricted funds which have been earmarked by the Trustees for particular purposes.
- *Restricted funds* comprise income which has been received for the objects of the church and specified for a restricted purpose within these objects by the donor.
