1. The provision, maintenance and insurance of the property at 52a Bowmont Street, Kelso for the Charitable purposes
2. The support of Kelso Evangelical Church
3. Support to the J-Team Children's Holiday Club
4. The provision of Christian literature and promotional material

Achievements and Performance

The Trustees are pleased to report that the premises at 52 Bowmont Street have been well used over the year, being in use most days of the week and for approximately 20 hours each week. Kelso Evangelical Church continues to express its gratitude for the use of the building and for its versatility for their different activities. They report that on some occasions it is reaching capacity, but that its functionality and location make it an ideal base for them. The Church has become increasingly self-sufficient and no monetary gifts were given this year, the Church entirely covering the cost of the J-Team Holiday Club through a freewill offering. While continuing to meet the necessary expenses relating to the use of the building, the Trustees are pleased to note this increasing financial independence.

- The Trust continues to meet the cost of utility bills for the building in order to maintain a comfortable and welcoming space for all users
- Insurance costs for the use of the building by Kelso Evangelical Church were met
- Broadband access was provided for all users, to enable livestreaming of church services, access to relevant resources, and for necessary administrative purposes.
- Maintenance of the property included the triennial painting of the building which was undertaken by volunteers.
- Investment was made into the up-grading of the hearing loop and the purchase of a more powerful data projector.
- The Trustees are pleased to have been able to meet the costs of hiring Kelso Swimming Pool on two occasions for baptismal services.
- Other groups making use of the building were the Royal Voluntary Service providing a centre for adults in danger of social isolation, a lip-reading class, and the Borders branch of the Trefoil Guild.



Independent Examiner's Report


