Structure, governance and management**Type of governing document**

The charity is an unincorporated association that is governed by its constitution.
The playgroup was granted charitable status by OSCR on 11 January 1995
The management committee is responsible for the strategic direction and governance of the playgroup, whilst day-to-day running is delegated to the playgroup manager and staff, who are all paid members of staff.

Trustee recruitment and appointment

The management committee meets on a monthly basis and are the Charity's trustees. Membership of the committee is open to all current and past parents and guardians of the children in the playgroup.

Election to the management committee is agreed and the AGM in accordance with the constitution. There must be a minimum of 4 members holding the following posts - Chair, Treasurer, Secretary and one other.

Objectives and activities**Charitable purposes**

The aim of the playgroup is to advance the education of pre-school children so that they may take a constructive place in the community which is in accordance with the aims of Early Years Scotland.

Summary of the main activities in relation to these objects

The playgroup provides education and care for two and three year olds in four sessions per week. At present the playgroup can accommodate up to 15 children per session.

APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

The charity has held 4 weekly playgroup sessions during the school term time for 2 - 3 year olds in the local community. The Playgroup Manager and staff have supported the children's development as follows:

- Provide a comfortable, safe and secure free play session
- Support inclusion and give all children equal access
- Develop close relationships with children
- Use everyday care routines to support development - provide healthy snack, daily exercise, outdoor play.
- Use different methods of communication - storytime, songs, eye to eye level with children
- Provide extra encouragement for children that require it
- Help children with strong feelings

The committee have held multiple fundraising events which have raised a total of £1,336. This figure is slightly lower than 2023 as our summer event was moved from June 2024 to August and therefore into the next financial year. Donations of £1,020 were received in the year. This fundraising income was used to improve the equipment inside including a sand table, new tuff trays and arts and craft material.

The trustees' policy is to maintain unrestricted restricted reserves at around 2 months running costs to meet commitments and to cover any unexpected expenditure. Our reserves currently meet this level.

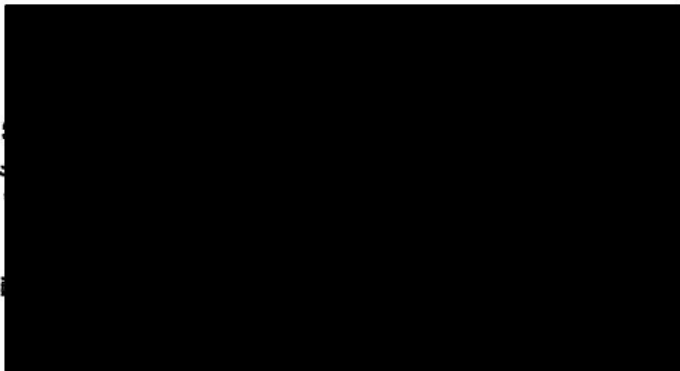
