Objectives: (1) To relieve poverty among the residents of the Isle of Tiree ('the Operating Area') (2) To advance education among the residents of the Operating Area, particularly among young people and the unemployed (3) To promote and/or provide training in skills of all kinds, particularly such skills as will assist residents of the Operating Area in obtaining paid employment (4) To provide in the interests of social welfare, facilities for recreation and other leisure time activity available to the public at large with a view to improving their conditions of life (5) To promote, establish and operate other schemes of a charitable nature for the benefit of the community within the Operating Area (6) To promote trade and industry, for the benefit of the general public
