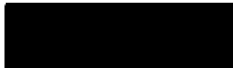

Structure, governance and management

The Deed of Trust for the Highland Foundation for Wildlife was registered in the Books of the Lords of Council and Session in Scotland on 9th June 1995.

Variation of Trustees recorded in Deed of Assumption and Resignation dated 5th January and 2nd and 15th April all in the year 2007 and Registered in the Books of the Lords of Council and Session on 24th April 2007.

The principal activity of the Trust is to promote, for the benefit in Scotland and elsewhere, the conservation of wildlife and the restoration of natural ecosystems.

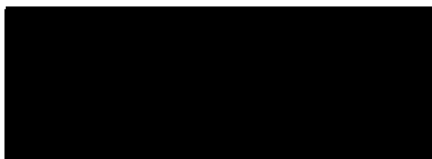
The name of the Trust was changed to Roy Dennis Wildlife Foundation in 2017.

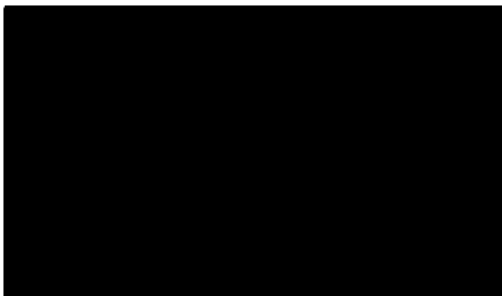
Independent Examiner's Report for the period 6th April 2024 to 5th April 2025

I have examined the Trustees' report, the Trust's accounting records, as set out on pages 4 to 7 that form part of this document.

To the best of my knowledge and belief, and in accordance with the information and explanations given to me:

- a. The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 Act and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.
- b. My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006.
