**Activities:** 'It carries out activities or services itself'

**Purposes:** 'the advancement of education', 'the advancement of the arts, heritage, culture or science'

**What the charity does:** Eastgate Theatre & Arts Centre is a community-focused cultural charity that exists to inspire, engage and change lives through artistic experiences. We provide a welcoming, accessible venue in the heart of Peebles where people can experience high-quality professional work and take part in creative activity. We deliver this through a year-round programme of live performance, cinema, exhibitions and festivals, alongside participatory and outreach work including youth theatre, inclusive dance and music, creative learning, and wellbeing-focused programmes for people living with dementia, disability and long-term health conditions. By working in partnership with artists, schools and community organisations, we support local talent, bring high-quality work to the Scottish Borders, remove barriers to access, and embed creativity at the heart of community life.

**Beneficiaries:** 'Children or young people', 'Older People', 'People with disabilities or health problems', 'No specific group, or for the benefit of the community'

**Objectives:** The objects for which the Company is established are: a) To promote, maintain, improve and advance public education by the encouragement of the arts, particularly by the promotion of dramatic and other arts including dance, drama, music, visual arts, crafts, burlesque, film and photography, plastic arts, graphics and design, mime, dramatic improvisation, ballet, sculpture and literature and to formulate, prepare and establish schemes therefor, provided that all objects of the Company shall be of a charitable nature. b) In the interests of social welfare, to provide or assist in the provision of facilities for recreation or other leisure

time occupation with the object of improving the conditions of life of the persons for whom such facilities are primarily intended being persons who have need for such facilities by reason of their youth, age, infirmity or disablement, poverty or social and economic circumstances provided that nevertheless such facilities shall be available to the members of the public at large.
