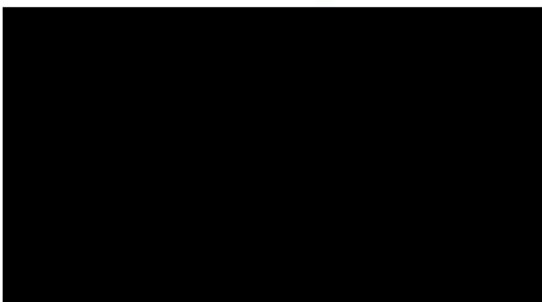

The Trustees present their report and the financial statements for the year ended 31 March 2025.

**Recruitment and appointment of trustees**

Trustees are appointed by the existing committee of trustees.

**Governing document**

The governing document was a Trust Deed and charitable status was attained on 1 October 1996. The Trust adopted a SCIO-based Constitution when they became a SCIO (Scottish Charitable Incorporated Organisation) in 2016.

**Charitable purposes**

The purpose of the Trust is to advance the education of the public by the provision, construction and subsequent management of a centre for the development of environmental education, conservation and preservation of the flora, fauna, geology and history of the area around Bennachie.

**Summary of the main activities in relation to these objects**

The Trust held 4 formal business meetings during the year; most have been a blend of in-person and online attendance, facilitated by the Smart board electronic system at the Centre. Several additional meetings were held, for specific issues including: installing a new card payment machine, development of additional educational display board content, planning upgrades to Centre equipment/displays, and updating spreadsheets used for accounts.

**Activities and achievements**

The Centre opened for the 2024 season on Friday 29 March. Problems occurred with the existing card payment machine for the shop, leaving the Centre unable to take card payments. Following unsuccessful efforts to resolve the situation, a replacement card payment machine was purchased from another company. The new system is cheaper to operate and has worked well over the year.

A 2025 calendar was produced to celebrate the 30<sup>th</sup> anniversary of the Trust and Centre, in collaboration with local schools and artists, featuring artwork interpreting Bennachie in a range of media. The calendars were sold in the shop, other local outlets, and online through the new card payment system, successfully raising funds for the Trust. A 2026 calendar is now being developed.

The Lord Lieutenant of Aberdeenshire visited in May, and Trustees showed him around the Centre and explained the Trust's activities. He was enthusiastic and complimented the Trust on the Centre facilities and educational value. [REDACTED] were subsequently invited, and delighted to represent the Trust at the Royal Garden Party, Holyrood in July.

A programme of public events providing opportunities to discover and appreciate the natural and cultural heritage of Bennachie, included a Creative writing workshop, a Needle-felting workshop, a pond life art class, an Art and Craft Fair (455 visitors), a 'Doors Open weekend' (247 visitors), and the Garioch Ranger held 3 public events (20 adults, 22 children). The Centre hosted NEOS (North East Open Studios) again, featuring 4 local artists and their Bennachie-inspired artwork over a week in September, attracting 1600 visitors.

**Activities and achievements (continued)**

Social media provided effective communication, with 4.5 k followers on the Bennachie Visitor Centre Facebook page. Events were also publicised through the Bennachie Community Council newsletter and Spotlight magazine. The Centre provided a venue for a range of educational courses, and supported events run by other bodies, including hill navigation (Hillgoers), wildlife identification skills courses, a hill race and the Bennachie Ultramarathon in October.

Educational display boards on conifer identification, hill safety and wildlife identification have been produced and further boards are being developed. A 'Birds of Bennachie' leaflet is currently being developed with a local artist. Work continues on upgrading electronics in the Centre, including linking internal screens to wildlife cameras (existing and new) and re-establishing the live-feed hill view camera, in conjunction with a specialist local firm.

Exhibitions at the Centre included the Homecoming Art Project, butterflies and moths, and artwork from the calendar. Other displays included: Pictish symbols, the Bennachie Air Crash, conifer identification, autumn leaves, and the Scottish Outdoor Access Code (SOAC), with interactive displays on 'discover the season', animal babies, nature alphabet and 'how many?'. Exhibition space was provided for local schools and organisations, with displays by Huntly Swift Group, Premnay Primary School, Westhill Academy and Inverurie Academy. The Garioch Ranger led 8 group events (76 adults, 112 children) and provided environmental education for 30 schools (104 adults, 843 children) through activities promoting discovery and appreciation of the natural and cultural history of Bennachie, improving the local environment and biodiversity, promoting benefits of accessing outdoors, responsible access and engagement of marginalised people.

Aberdeen Mountain Rescue equipment is now stored at the Centre, since Bennachie is a frequent location for emergency call-outs, and discussions on provision of safety training are underway. The Trust continues to liaise and work with the Bailies of Bennachie in support of shared objectives, providing facilities for public events and noticeboard space in the Centre, and receiving assistance from Bailies work parties when requested for outdoor works. The Community Pay Back Team painted wooden outdoor features and cleared weeds from the courtyard. Trustees also weeded the courtyard through 2024 and before the 2025 opening.

The Centre maintained its 4-star rating with the Visit Scotland Quality Assurance Scheme in 2024, but the scheme ended in March 2025. Work continued to improve the visitors' experience, featuring the BCT brand and raising the Trust's profile. Visitor numbers to the Centre remained around 30,000 for the season, similar to last year. Visitor comments continued to indicate high satisfaction levels, and the community room had 42 bookings. As part of the strategy to increase visitor numbers and community room use during quiet times, a group visit package featuring a talk/event and refreshments, has been produced and is advertised by poster and on social media.

The Trust increased the annual contribution to Aberdeenshire Council, for services including rent, electricity, waste, water servicing and contribution towards staffing. The Trust also substantially contributed towards upgrading and maintenance costs for the Centre, including the hot water system, plumbing and alarm systems, and funded new taps in the public toilets and courtyard wall repairs, with stones gathered by a Corporate volunteer group. Work is ongoing to improve internal lighting, and to update orientation panel and interactive displays.

Public toilet access continued to be provided when the Centre was closed over winter. Forestry & Land Scotland discontinued their longstanding provision of bird food for the wildlife viewing area, and the Trust is exploring ways to cover the additional costs, including targeted donations. Efforts to increase income from shop sales with an expanded range of goods continued; new items include a range of Field Studies Council laminated identification sheets, BVC-branded giftware, artwork by local artists and a 'Bennachie Brew' rewards scheme to encourage coffee sales. A new shelving unit was purchased, providing better display space, and a new display freezer. Additional ways of improving the retail space are under consideration.

Fundraising by the 'heart appeal' continued, selling items with the heart logo, to cover maintenance costs of the Public Access Defibrillator (PAD) at the Centre. A substantial anonymous donation has funded items to improve the wildlife viewing experience, including live feed cameras, interactives, new feeders, a water feature, storage containers and new educational display boards. The Bennachie Ultramarathon event organisers also donated a significant sum, and other large donations were received from Hillgoers, NEOS artists, Craft Fair stallholders and hill race organisers. The Trust is very grateful to all donors for their generous gifts. The Trust is also participating in schemes providing money for recycling computer ink cartridges, and for old equipment/foreign currency etc. At her retirement presentation, the Trust thanked Lorna for 30 years of excellent cleaning service at the Centre.

The Centre opened for the 2025 season on Saturday 29 March.

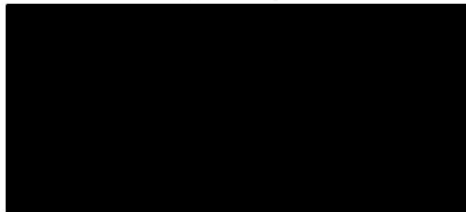
**Financial review**

**INDEPENDENT EXAMINER'S REPORT TO THE COMMITTEE OF  
BENNACHIE CENTRE TRUST**

I report on the accounts of the charity for the year ended 31 March 2025 which are set out on pages 6 and 7.

**Respective responsibilities of committee and examiner**

The charity's committee is responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.
