- **GOVERNING STATEMENT:**

IDARA TALEEM-UL-QURAN TRUST is a registered charitable organization and was formed and established in 1989.

- **CHARITABLE PURPOSES:**

The trust/organization works on self-help and funding basis. It provides a wide range of services to members of the Muslim community in particular and to other communities in general. It is also always ready to serve whoever wishes to benefit from its services.

- **REGULAR SERVICES:**

The Idara Trust provides the following services on regular basis:

- Making arrangements and providing necessary facilities for congregational prayers, five times a day, all year round. Publication and free provision of prayer timetables.
- Special arrangements for Friday and Eid prayers and also Taraveeh prayers during the holy month of Ramadan.
- Organizing religious festivities and other Islamic programs.
- Providing additional facilities necessary for the elderly, children & disabled and women during prayers and other programs.
- Separate arrangement for religious, ethical and moral education for Muslim boys and girls from Monday to Thursday from 5pm to 7pm. Additional weekend

- Classes are also held on Saturdays and Sundays from 12pm to 1pm. Total Current number of students attending are at 50 in all weekday & weekend classes.
- Library services together with publication and free distribution of religious material including prayer charts, pamphlets, illustrated Hajj and Umrah guides to name a few and lending of books to members of the Muslim as well as other communities.
- The Idara Trust has also printed and distributed free of charge pocket size guidance/information booklets with help from local sponsors.
- With the help of the local Muslim community, during the holy month of Ramadan we provide a three-course meal to open fast and provide food to keep fast free of charge for all, irrespective of religion or faith.
- Arrange educational and fun tours to historical attractions
- Charity is registered to perform all types of marriage ceremonies and Engagements as laid out in the Marriage & Civil Partnership (Scotland) Act 1977, 2014 & 2023.
- **UPDATE FROM PREVIOUS YEAR'S TRUSTEE'S REPORT:**

Welcome to this year's trustee report update, all is going well with the new look renovation and donation pay stations, The charity is in discussions about how to implement further ideas & innovations to advance the charity.

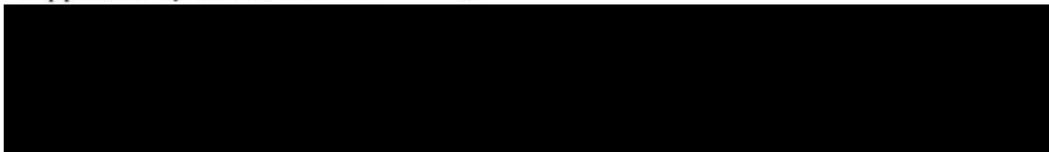
The charity still does after prayers evening talks & gentle reminders to encourage the growth number of the congregation to the local community and addresses any local community issues & concerns.
