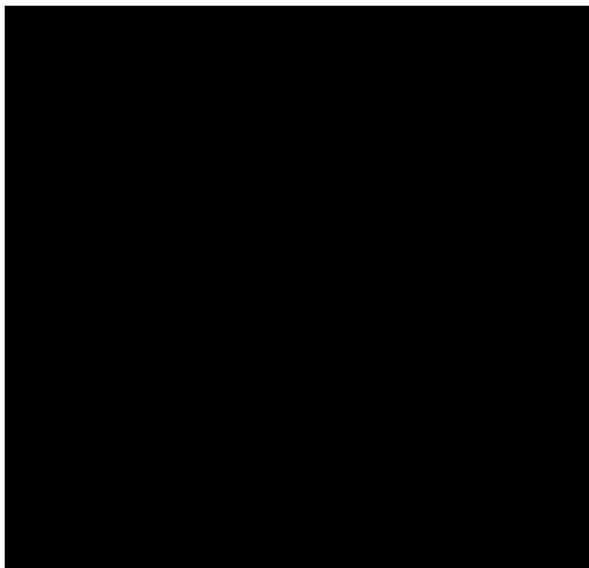

Objectives and Activities (Continued)

We usually hold fund raising events throughout the year- a Federation Show when members compete in Home Skills, Handicrafts and Floral Art competition. Quiz. The members also compete in various sports - walking netball and ruralympics, with the winning teams representing Perth and Kinross at the national finals.

We have a subcommittee. The Skills and Events Committee which promotes the preservation of Scotland's tradition and heritage and the education and training in home skills, rural domestic economy, family welfare and citizenship.

Junior Dippers attend meetings every month where they participate in many crafts in the hope they will carry on the skills and most of all joined the organisation when they come of age.

Achievements and Performance

In June we attended the Annual Area Lunch where members got together with members from Fife & SCWP Federations. A fun quiz was held in June to help cover costs of sporting competitions. We had a stand at Perth Show to promote the SWI & encourage new members. We held a very successful Federation Show in October with the schedule being carried forward from the previous year after that show having to be cancelled due to weather conditions.

No main fundraising event was held this year as it was felt the Federation Show had raised enough funds.

Junior Dippers have continued to meet every month, participating on different crafts, being demonstrated mainly by our own members.

Walking Netball has continued to be popular & meet twice a month, enjoying each other's company & keeping fit.

The Executive continues to meet over zoom, keeping the cost of travel & hall hire to a minimum.

Financial Review

Excess funds are deposited in Fixed Term Deposit accounts and are rolled over on maturity, accumulating a small amount of interest. One matures every six months and the other, from which we receive annual interest into the current account, every two years.

A levy of £5 was collected from each member.

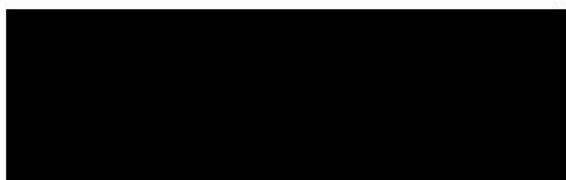
Basis of Independent examiner's statement

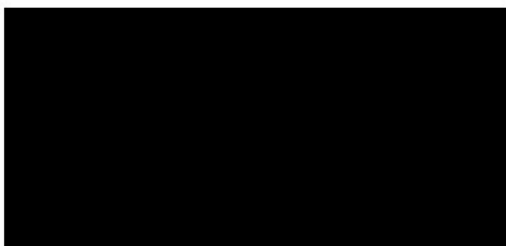
