The Kilncadzow Village Hall Association is a Scottish Charitable Incorporated Organisation. Our objects as recorded in our constitution are the provision of recreational facilities or the organisation of recreational activities with the object of improving the conditions of life for the persons for whom the facilities or activities are primarily intended.

Committee Members are appointed by the Members at our Annual General Meeting which was held in the hall.

In the course of the year further improvements have been made to the hall with grant funding of £9,504 secured to fit a new kitchen along with the associated plaster and joiner work, flooring and a new fire door has been fitted.

Thanks to kind donations from Bryson Tractors and local businessman [REDACTED]

[REDACTED] a Defibrillator has been installed.

As a result of these significant improvements, usage of the hall has increased with a number of bookings and very well attended and enjoyable events including 3 whisky tasting evenings, a talk on the history of the village, commemoration of the 80<sup>th</sup> Anniversary of VE Day and a Quiz Night.

The Hall has also been used on a regular basis by the Carpet Bowling Club and let on occasions to other Groups eg Carluke Young Farmers.

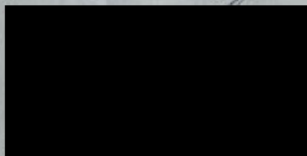
To build on the progress made during 24/25 governance arrangements will be kept under review and work will be progressed to improve the toilet facilities.

INDEPENDENT EXAMINER'S REPORT ON THE ACCOUNTS OF  
KILNCADZOW VILLAGE HALL ASSOCIATION

1<sup>st</sup> AUGUST 2024 to 31<sup>st</sup> JULY 2025

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Regulations 2005 Act and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(e) of the Act and to state whether particular matters have come to my attention.

My examination is carried out in accordance with regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently, I do not express an audit opinion on the accounts.

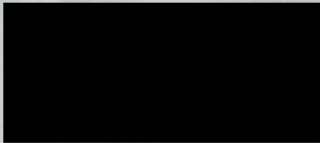
In the course of my examination, no matter has come to my attention
