Notes to the Accounts – For the Year Ended 31 March 2026

1 Basis of Accounting These accounts have been prepared on the Receipts and Payments basis in accordance with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

2 Nature and purpose of funds Unrestricted funds are those that may be used at the discretion of the trustees in furtherance of the objects of the charity. The trustees maintain a single unrestricted fund for the day-to-day running of the Club.

3 Surplus funds not required to support charitable activities are donated to the National Trust for Scotland

4 Trustees have not claimed any expenses.
