Our purposes, as recorded in our trust deed, are to provide funds for the relief of poverty, sickness and distress, the promotion of medical research, the promotion of the arts, the advancement of education, the conservation and protection of the natural environment and endangered species, the welfare of sick and neglected animals and relief for the victims of war and natural and civil disasters.

Activities and achievements

Donations of £126,000 were made in the year to national charities which support the aims of the charity.

The investments held increased from £3,478,026 to £3,921,789 at the year end. The investment objective is a combined return from income and capital growth.

Trustee remuneration and expenses

The trustees did not receive any remuneration or expenses during the year.

Related Party Transactions

There were no related party transactions during the year.

Reserves

The trustees intend to keep the capital intact and distribute any income. The unrestricted funds of £292,499 at the year end are the result of the legacy received in previous years.

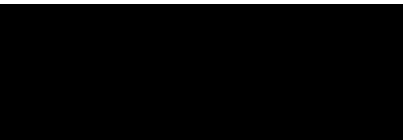

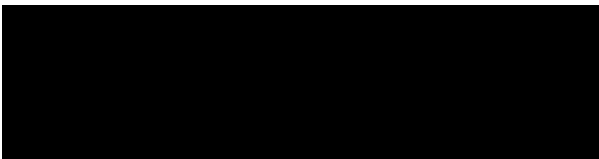

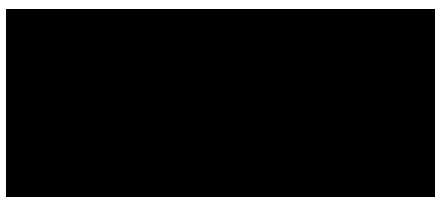
