The objective and aims are to raise funds for the advancement of education, health, community developments, the arts and sport.

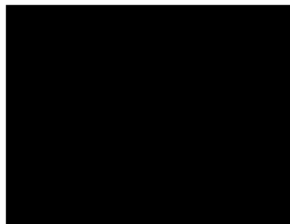

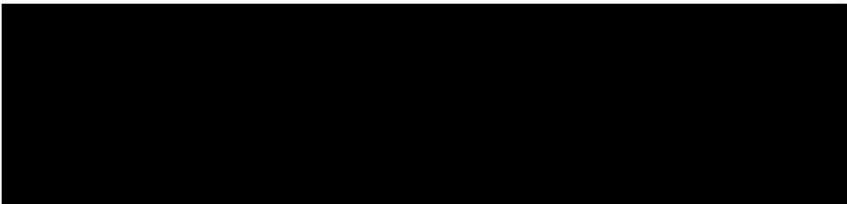

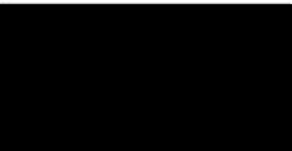
Independent examiners qualified statement

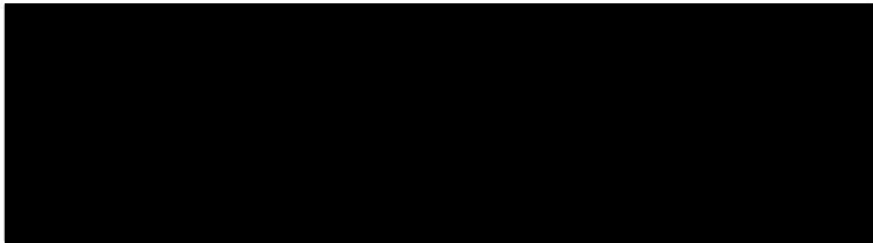
