Our members are elderly or disabled and some have learning difficulties. Some members come along with a carer.

We moved from St John's Church Hall on Friday 6 February as there was problems with their heating. We moved to the OAP Hall in Chapel Street on Friday 6 February 2026. We then got availability on a Thursday evening at the OAP Hall which made it easier for the Entertainers as some of them have other commitments on a Friday night. We meet from January to May and then start again from September to December.

Achievements and performance

Summary of the main achievements of the charity during the financial period

We provided entertainment each week for elderly, disabled and members with learning difficulties which usually consists in entertainers coming to play music which members can dance to if they are able to do so. We provide a supper of sandwiches, cakes, tea, or coffee. We had a Burns Supper in January, a Halloween Party in October and a Christmas Party in December. We had trips in the summer for a high tea.

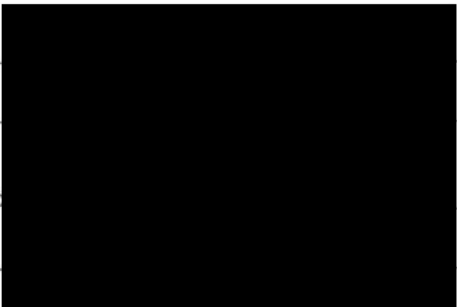
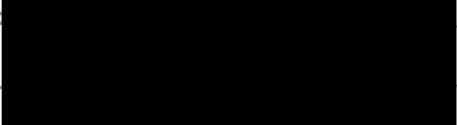

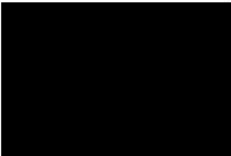

Our members include elderly, disabled and some have learning difficulties. Some members come along with a carer. We have members from SENSE Scotland who are either blind, deaf or in a wheelchair and are brought along with carers.

Charitable purposes

Our purposes as recorded in our constitution are to provide entertainment to the elderly, disabled and people with learning difficulties in the Forfar area.

Summary of the main activities in relation to these objects

We meet in St John's Church Hall on a Thursday evening from January until May and then start again in September until December. We normally have 3 outings in the summer, one in June, one in July and one in August. We have our annual Burns Supper in January and a Halloween party in October and Christmas party in December.

We provide a lovely supper and have entertainment most Thursday nights or have a game of bingo or play games. We sometimes have a quiz.

Achievements and performance

The committee take it in turns each week to provide the supper for the members and guests but are only paid to cover their costs of providing sandwiches, baking, or buying cakes.

Sometimes the entertainers provide the supper.

Some of the entertainers are groups from local churches, other entertainers are the Rotary Club and the Inner Wheel. We also have Country Dancers, young highland dancers too and people who come and entertain us from the Angus area and Dundee.

We had a Steel Band, a Church group from Brechin, who were excellent. We have had the Dee Ukes, a ukulele group from Dundee, the Carnoustie Traditionals who come along to entertain us.
