REPORT OF THE TRUSTEES FOR THE YEAR ENDED 28 FEBRUARY 2025**

The trustees are pleased to submit their Report and Accounts for the year ended 28th February 2025.

This year has been another solid year for ADA Scotland.

Our administrator Miriam Doren is working hard to promote and develop our charitable mission.

However, the board has suffered some big shifts in the personnel which has resulted in the late submissions of these accounts.

These include, due to personal reasons, the resignation of our wonderful Chair, Caroline Jacquet.

We are grateful for her hard work, both our members and the committee have enjoyed working alongside her.

Unfortunately, despite not having been with the committee for long, our new treasurer Lyn, also had to resign.

The committee once again is grateful for what Lyn was able to offer in her short tenure.

However, the committee have, in the interim, set up groups to look at training, finance and auditing with meetings to follow this. The Committee is also delighted that Amanda Foster, our Vice Chairperson has agreed to step up as Chair from May 2025.

We were very lucky in our last set of accounts, to show a successful funding bid from the People's Postcode Lottery. This continues to sustain the position of administrator, though it is clear that we must continue to seek out funding and diversify our income model if we are to continue, as the accounts for this year do show an operating loss.

Plans for the coming year include the application of several funding bids, the temporary re-appointing of Dani Rae as our treasurer while we recruit for others with the necessary skillset. We continue to promote the charitable mission, and over this financial year have been delighted with the increase in cultural events looking to add Audio Description to their output and looking to us to support that.

OBJECTS OF THE CHARITY

The charity is known as Audio Description Association. The objective of the association is to relieve the suffering and distress of the blind and partially sighted arising from their inability to participate in theatre, cinema, sport and associated subjects.

SIGNIFICANT ACTIVITIES AND FUTURE DEVELOPMENTS

Income

Membership

Corporate Membership sign up increased throughout 2025, we have received Membership subscriptions from 23 (up from 8 in the previous year) Corporate Members and 40 Individual Members (up from 27), which gives a total Membership Income for the financial year of £3,004 (Previous Year £2,938). With a view to streamlining administration, memberships were brought into line with a single renewal date. This meant that some who had joined towards the tail end of the previous year were given a pro-rata rate to bring them

Donations

Donations came in from Saint & Sinners and Amazon Europe Core. Donations decreased in 2025 totalling £1,970 compared to 2024 £1,019.

Hire of Equipment

There was no hire of equipment in the 2025 financial year.

Total Income

Our Total Income for the Financial Year is £4,974 (Previous year £17,136).

Expenditure

Our Expenditure for the financial year is £11,500 (Previous year £7,930).

This includes Website expenditure of £1,808 which relates to the upkeep of the website throughout the year, and the updating of listings. Discussions have been had with the company supporting the website and it is recommended ADA (Scotland) look into finding funds to support the development of a new website that could be managed in house, thus saving funds in the future. Funding will need to be sourced for this, and for the post of Administrator which totalled £7,610. This is by far the biggest outlay, but is certainly responsible for the increase in incomes across the year as capacity has ensured the promotion of the charity and its services, as well as better credit control.

Governance costs are £420 for the year to date and includes the fee for the independent examination of our annual accounts by accountants AD+ in Glasgow.

The detail of our expenditure for the financial year is shown within the attached Receipts and Payments Account.

Summary

As a result of the above our total reserves at 28th February 2025 are £13,876 which leaves the Association in a healthy financial position.

Of the above total we have unrestricted funds of £11,747 and Restricted funds of £2,129. The Restricted Funds are in respect of the balance remaining on the Aberdeen Association funds and have been designated to cover future training expenditure in Aberdeen.

Our Unrestricted Reserves of £11,747 shows that despite better credit control and increased incomes following the end of the Covid-19 pandemic, there is still some way to go to bring finances back to pre-pandemic levels. With increased costs, there is a case for funding to be sought alongside increased memberships and equipment hire. The Committee is seeking ways to ensure we are able to continue to promote the profile and standards of audio description nationwide.

Independent examiner's report to the trustees of Audio Description Association (Scotland)
