Trustees' Annual Report for the year ended 31 December 2024

Structure, governance and management

Governing document

The Association is administered in accordance with the terms of its Deed of Constitution.

Recruitment and appointment of Trustees

All the Association's Trustees are appointed or re-appointed by the members at the Annual General Meeting, which is held in April each year.

Purposes

Our charitable purposes:

- To encourage, by charitable means but not otherwise, the protection, preservation, restoration, research, study and appreciation of Scottish castles, tower houses and manor houses, together with their associated furnishings, settings, gardens and designed landscapes being of merit or historic interest and situated in Scotland
- To co-operate with other bodies with similar aims
- To do anything which may be considered to be incidental or conducive to the attainment of all or any of the objects

Summary of the main activities and achievements of the charity

This year our Council has implemented key initiatives that will create a firm foundation for continuing to meet our charitable objectives in the years ahead, encouraging the protection, preservation, restoration, research, study and appreciation of Scottish castles, tower houses and manor houses and their furnishings, settings, gardens and designed landscapes.

Governance review

We conducted a review of our governance, which included reviewing and revising our Constitution to reflect best practice in the charitable sector, in accordance with guidance from OSCR. The new Constitution was based on the model constitution produced by the Scottish Council for Voluntary Organisations (SCVO), of which the SCA is a member. It was approved at our 2025 AGM. Our governance review set out clearly the roles and responsibilities of our Trustees – every member of the Council is a Trustee of the SCA. We developed policies and guidelines including a Privacy Policy, Conflict of Interest Policy, an Equality Diversity and Inclusion Statement and Risk Assessments.

Reserves Policy

We implemented a Reserves Policy which set optimal free reserves at a figure equating to 18 months of unrestricted expenditure. We used a risk-based approach to calculate the optimal free reserves that we required to address unexpected costs and opportunities. We considered reliability of income, costs of re-organisation activities and specific liabilities, taking into account risks we are aware of and contingencies, e.g. for our archive project (see below). We also have designated reserves, for funding the archive project, and restricted reserves that relate to income to be used for the specific purpose stipulated by the donor.

New SCA website

We developed a new SCA website that will promote our charitable purposes, showcasing our activities and enlisting support through membership, partnerships, volunteering and donations. Website development was supported by a generous donation from two of our members. The site will be launched in summer 2025.

SCA Online Castles Archive

We began to create the Scottish Castles Association Archive, which will be a leading repository and research tool for Scottish castles. Due for launch in late 2025, it will be available online to anyone in the world with internet access, free of charge. At its heart will be the Bogdan Brothers' Scottish Castles Archive, our unique legacy of research material from archaeologist [REDACTED], our former Chair. Together with other collections gifted or loaned to us, this constitutes an archive of national and international importance. We are working in partnership with the Stirling University Archives and Special Collections department to classify, digitise and protect all the material, which includes previously unseen images and texts. We have begun work on a fundraising initiative to ensure we can sustain our digitisation programme and continue to attract new archive material.

Our Journal

We welcomed our new Editor, who developed a revised format for the Journal to reflect all our charitable purposes. The first issue of the new edition will be published in late 2025.

Conference to encourage castle restoration and use

We worked with Historic Environment Scotland and the National Trust for Scotland to convene a conference, *Scottish Castles – Use Them or Lose Them*, which will take place in Stirling in late 2025. The conference will explore how current planning process can be applied to encourage more people to restore and

re-use Scottish castles and other historic buildings. It will be open to everyone with an interest in castles - restorers, planners, historians, craftspeople, conservation professionals and castle enthusiasts. The conclusions from the day will be taken forward by a working group to help reach consensus on how planning process can be applied to provide a useful and sustainable future for Scotland's built heritage.

Extending the reach of our castles visits and study tours

Our castles study tours continue to prove popular. Our Autumn 2024 Tour to the Black Isle and Nairnshire was well supported and our Spring 2025 Tour of Ayrshire was fully subscribed in the space of 48 hours. However, not everyone can attend a tour, and this year we broadened our reach by launching the SCA pop-up – a day at one or two castles in response to invitations. Pop-ups are ideal for those who cannot commit to a whole weekend tour or an overnight stay.

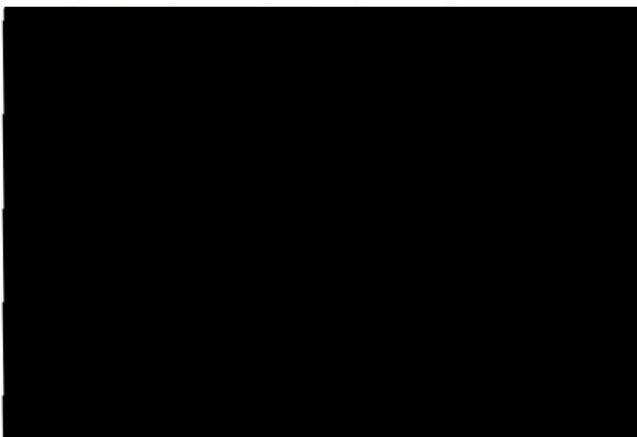
Basis of Independent Examiner's Statement
