To relieve the suffering and distress of the people in Glasgow, Tupelo, Mississippi and Memphis, Tennessee, who may suffer from the effects of poverty. The Trust endeavors to do this by operating a music programme created 8 January 2014 to offer acoustic guitars and guitar lessons for young people (5-18years).
