FOR THE YEAR ENDED 30 SEPTEMBER 2025

The committee presents their report and the financial statements for the year ended 30 September 2025.

Structure, Governance and Management

The management committee are the charity's trustees. The Association was established under the constitution founded on 13 June 2001 and is a registered charity. The constitution was updated on 3 March 2007 to incorporate the change of name of the charity. The charity was then known as Gartly Community Hall. The constitution was updated on 24 April 2012 to change the audit requirement to the accounts being subject to external scrutiny by an independent examiner. The constitution was further updated on 10 November 2014 to incorporate a further change of name to the charity. The charity is now known as Gartly Community Association.

Any person who wishes to become a member must lodge a written application for membership to the management committee for consideration. The election and re-election of members of the management committee takes place at the annual general meeting. New trustees receive informal advice and information from existing trustees regarding their duties and objectives of the charity.

Objectives and Activities

The objectives of the charity shall be to promote the advancement of community development within the Parish of Gartly including rural or urban regeneration and promotion of civic responsibility, volunteering, the voluntary sector or the effectiveness or efficiency of charities. The association aims to provide recreational facilities, or assist in the provision of facilities to uphold the traditions of Gartly Community Association with the object of improving the conditions of life for the persons for whom facilities or activities are primarily intended. Through these objectives the association endeavours to provide the advancement of the arts, heritage and culture.

Achievements and Performance

The association has continued to host a variety of events. The hall has been used for private hire and for fundraising events organised by the committee to pay for running costs and maintenance.

The association continues to have an Independent Review/Examination.

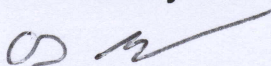
Financial Review

REPORT BY THE INDEPENDENT EXAMINER
OF GARTLY COMMUNITY ASSOCIATION

Respective Responsibilities of Trustees And Examiner

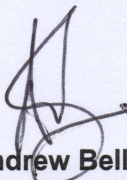
Basis of Independent Examiner's Statement

The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

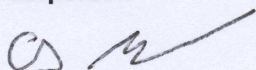
