APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

The new pontoon extension is now well established. Summer 2025 saw long periods of fine weather, in which the berthing facility was well used by small boat owners together with a number of smaller commercial vessels. Some visiting craft also made use of the sheltered berthing. No new subscriptions were sought or received during the reporting period. Maintenance and mooring requirements are accessed in the spring of each year, with any works required being carried out during the summer.

The former Uyeasound Boating Club storage shed at the Westside pier is in very poor condition and has now been considered by the Waterfront Trust to be beyond economic repair. A decision has been taken by the trustees to remove the shed from its site and reinstate the grounds. Service providers have been asked to end all building supplies. Owners of all boats still stored within the shed have been made aware of the proposal and have been asked to make alternative arrangements to store their boats. When these actions have been completed, we will make arrangements to have the shed removed.

Our application to Crown Estate Scotland (CES) to draft a new lease which takes account of the walkway extension is moving forward at a very slow pace. We have been notified that a new agent has been appointed at Bidwells to take this forward on behalf of CES, but no documentation has been received during the reporting period. We continue to monitor the situation and await receipt of the draft lease from them.

We remain cognizant of the potential availability of grant funding for further improvements to our berthing facility, alignment of our requirements with funding agencies criteria can be a challenge.
