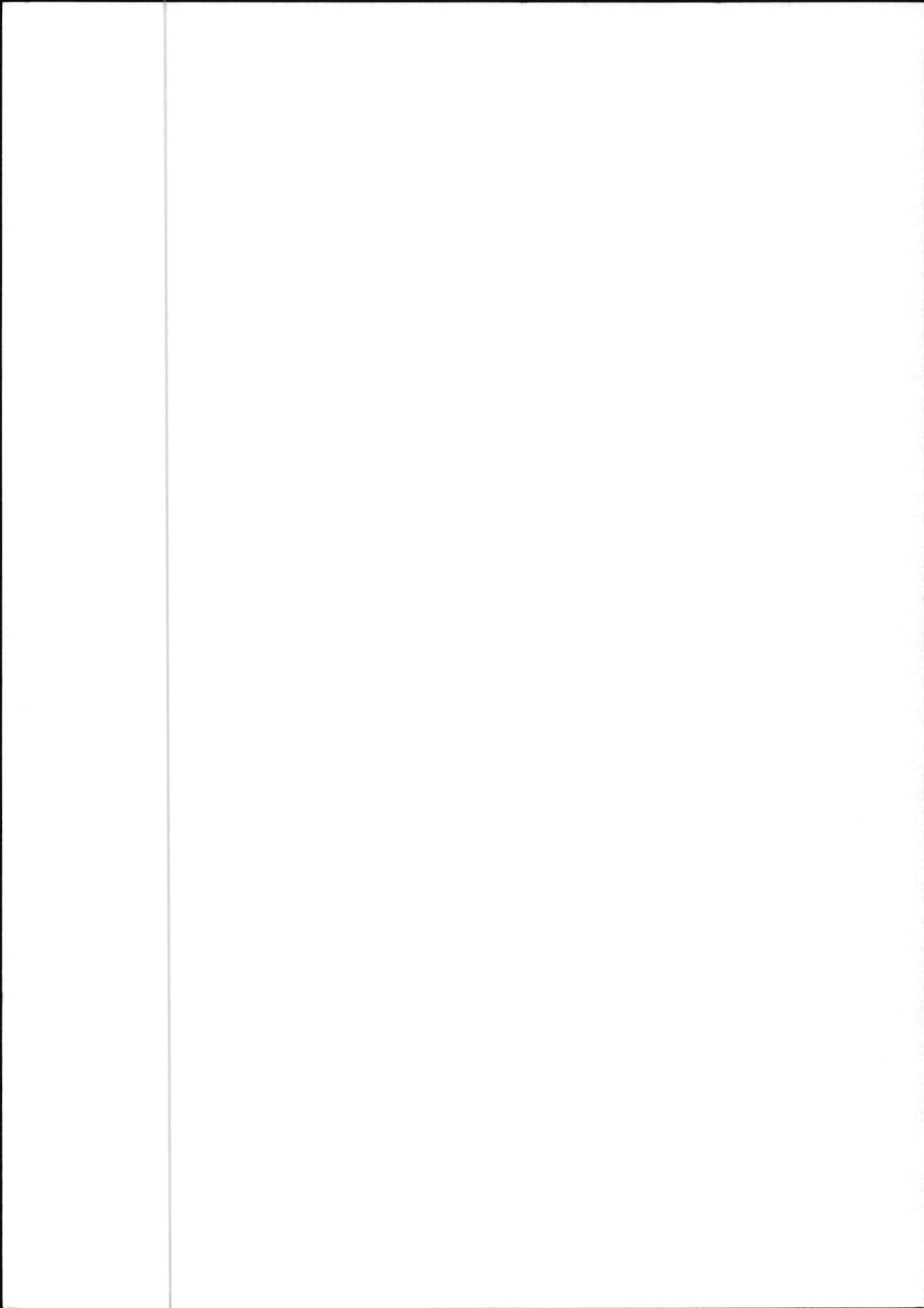

During the year the trustees did not receive any remuneration.

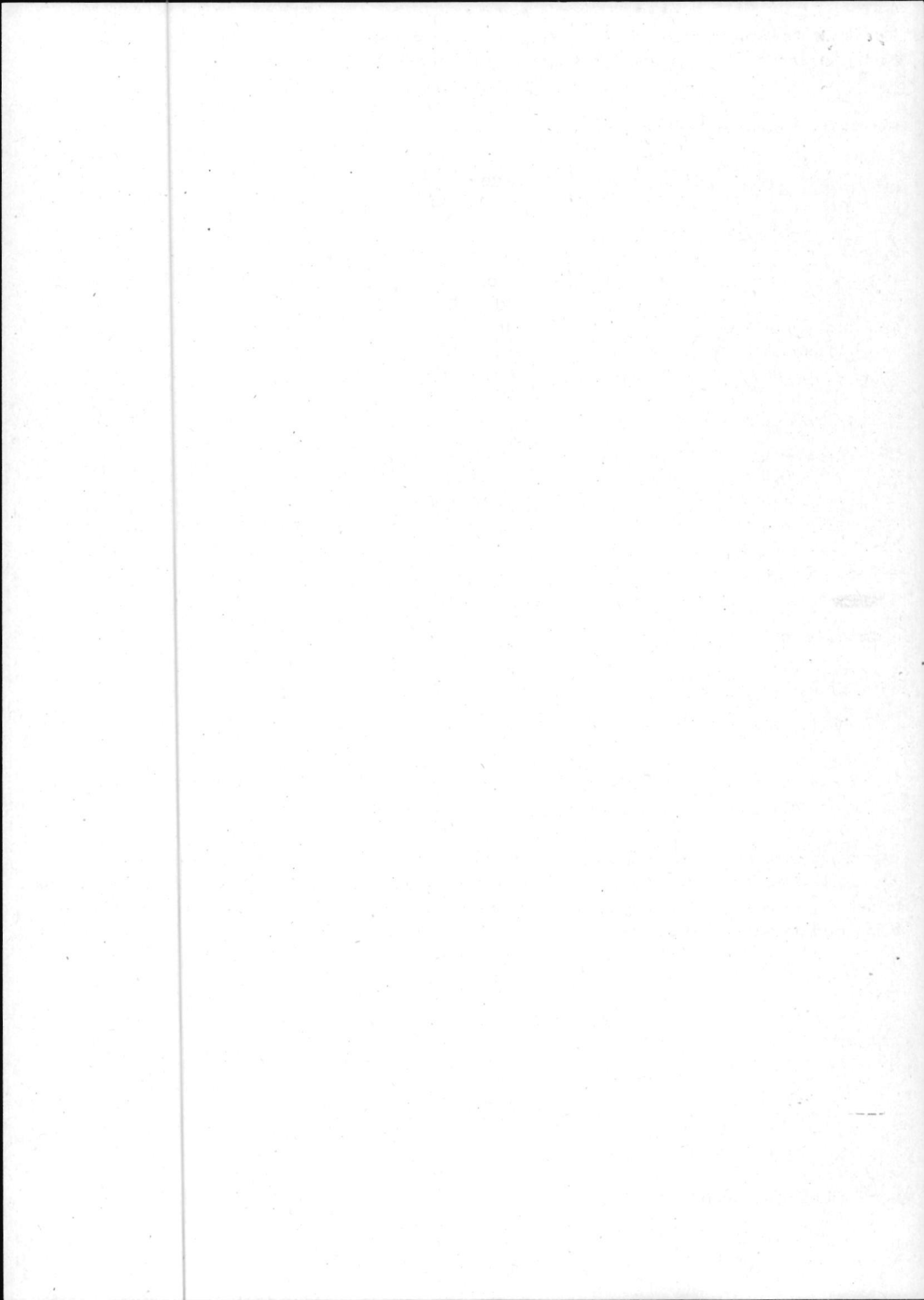

- 2 to which, in my opinion, attention should be drawn in order to enable a proper understanding of the accounts to be reached.

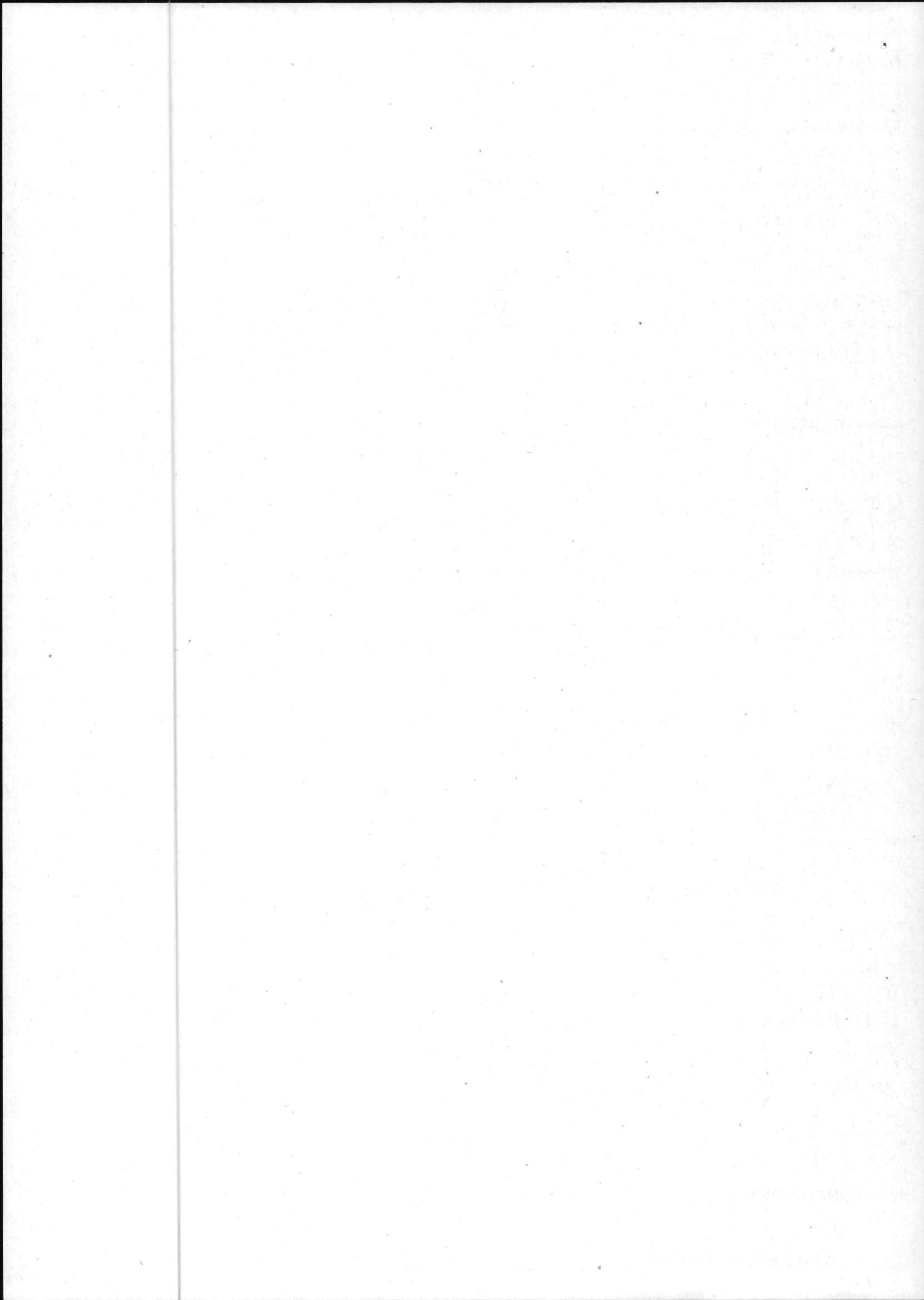
