Chairman's Report 2024

Aims and Objects of Sons of Thunder:

It has been pointed out by OSCR that the original governing document of Sons of Thunder hadn't been reviewed since inception, 25th January 2002! OSCR in its analysis of our most recent annual report suggested we update and revise our Governing Document, particularly to make it more relevant to what we do! At the 31st October 2024 meeting of trustees it was agreed that the original aims etc. were a bit too narrow and didn't properly represent what we as a charity are trying to achieve. The revised text is as follows:

"The object of Sons of Thunder shall be to promote where possible the word of God and the love of Jesus Christ through performance of music and to raise money for, and raise awareness of, HIV/AIDS orphans in the area of the CCAP Hospital, Ekwendeni, Malawi.

In order to achieve these objects the association aims to produce, distribute and /or sell recordings of songs, perform live concerts and participate in other fundraising events that are deemed appropriate."

I think this alteration covers our purposes more clearly.

In 2024 we received some very generous donations which enabled the charity to send another £3,500 to the HIV/AIDS Orphan Care Project in Ekwendeni, Malawi.

Again, we were unable to hold another fundraising 'Kovwirana' concert during 2024 but fortunately we have maintained a significant level of support to Ekwendeni.

Without this generous support Sons of Thunder could not assist many of the poor, disadvantaged and under-privileged in Northern Malawi, one of the poorest nations in the world. We wish to thank all of our donors for their generosity.

Structure, governance and management

Type of governing document: Sons of Thunder is a constituted charity recognised by the Inland Revenue for the purposes of *Section 505 Income & Corporation Taxes Act 1988* with effect from 25th January 2002, entitled under Section 1 (7) of the Law Reform (Miscellaneous Provisions) (Scotland) Act 1990 to describe itself as a Scottish Charity.

Trustee recruitment and appointment: The Charity is managed by a committee of trustees which meets a minimum of six times per annum. Additional trustees can be appointed by the committee.

Objectives and Activities

Charitable purposes: Throughout 2024 with support from our main donors, Sons of Thunder was able to send £2,000 to Malawi. (In Malawi, even a small amount of money can go a long way)

Summary of the main activities in relation to these objectives:

As noted in the Chairman's Report on page 3, the main annual fundraising 'Kovwirana' event was again not held in 2024 however with donations received elsewhere, including a £100 monthly standing order from friends within the Langside Church family, the charity is still supporting the work of the HIV/AIDS Orphan Project in Ekwendeni.

Achievements & Performance

Summary of the main achievements of the charity during the financial period: Raising £4,306.16 in donations and Gift Aid tax re-claimed, and sending another £2,000 to the HIV/AIDS Support & Care Program in Ekwendeni, Malawi in March 2024. (Note that we sent a further £3,000 to the HIV/AIDS Programme at Ekwendeni Hospital in February 2025, in the next financial year)

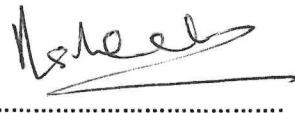

Basis of independent examiner's statement

It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

- to which, in my opinion, attention should be drawn in order to enable a proper understanding of the accounts to be reached.

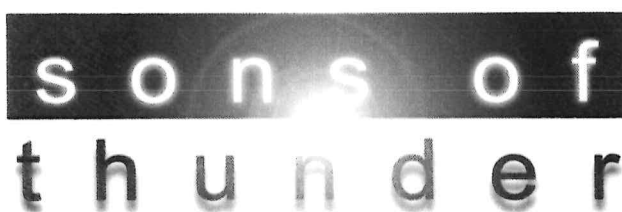
