Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution (Unitary Form).

Recruitment and Appointment of Trustees

Members of the Kirk session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation.

Organisational Structure

The Kirk Session is chaired by the minister and meets four times in a year. Certain responsibilities are delegated to the Finance Committee and the Property Committee as appropriate. The Kirk Session is responsible for spiritual and temporal affairs within the church.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Achievements and Performance

Events:

The Church again provided a sales table for the lent lunches held in aid of Christian Aid in March.

A Sponsored Walk was held in August and a Big Breakfast in November open to all.

Songs n Scones morning events were held regularly throughout the year, open for all to attend.

Hand of friendship joint lunch with St Michael's Church.

Mince Pies and Coffee were provided for all to attend in December.

Carol Singers, with mince pies, joint event with local community council was also held in December.

Groups/Meetings:

Session Meetings were held regularly throughout the year. The Stated General Meeting was held in May.

Financial Review

Overall, the church had a small surplus this year of £1,221 mainly due to bank interest income helping cover the losses from the day to day expenditure. The deficit in the general account required money to be transferred from the Fabric Account to provide cash flow and to ensure expenses were covered. At the end of 2025, the balance of the General Account was £9,994.05. While the Fabric Account balance was reduced to £15,035.31

General Account:

Despite fundraising efforts continuing as previous years our outgoings were greater than income by around £2,750. £4,500 was transferred from the Fabric Account, enabling cover the deficit and have a working balance over the year. The account had a balance of £9,994.05 at the year end.

Income: The income for 2025 increased by around £2,000. This included an increase of £677 through the generosity of the congregation; an increase of £987 in gift aid from last year and an increase of £403 from fundraising events.

Expenditure: Reduced from last year by around £3,400. This was made up of some reductions and some increases. Increases were to Giving to Grow, Pulpit Supply, Presbytery dues, Insurance, Organist costs, Council Tax increase. Some of this was mitigated by the shared costs of the minister now we are linked with St Michael's church. Reductions were made by having a new electricity contract and receiving refunds from amounts paid to the old contract, an overall reduction in spend for electricity of, £2,021. The other main reduction was in spend for stationary of £381.

Fabric Account:

Spend from the fabric account was £1,715, this takes account of St Michael's contribution to spend on the Manse. Income to the account was £3,236. Therefore income over expenditure was £1,521. This helped to reduce the impact of transferring £4,500 from this account to the general account to cover day to day expenditure. After transferring the £4,500, the year end balance left in the Fabric account was £15,035.31

Looking Ahead:

Looking ahead, expenditure will continue to be higher than income, but this is much less than the last two years. Using reserves if required, the church is in a better position, not least because of the generous legacy bequeathed in 2024.

Reserves Policy

It is the Trustees' policy to hold reserves of approximately six months expenditure including designated funds. At the year end the Church held unrestricted cash funds of £86,528. Whilst this represents just over two years expenditure, it should be noted that £59,059 of this relates to a legacy provided in 2024. The increase in general running costs along with reduced income will require funds to be used from reserves to be able to afford running costs in future years.

The Church also held £5,317 of restricted funds and £39,750 of endowment funds which have been provided for the purposes specified in Note 10.



Financial Review

Overall, the income (jointly for the current account and the fabric account) was £5,140 less than expenditure. Funding was required to cover the deficit and therefore money was transferred from the Fabric Account to provide cash flow and to ensure expenses were covered. At the end of 2024, the balance of the General Account was £6,277.20. While the Fabric Account balance was reduced to £18,837.51.

General Account:

Despite fundraising efforts continuing as previous years our outgoings were greater than income by around £8,200. This gap was covered during 2024 by transferring £8,000 from the Fabric Account, enabling this account to have £6,277.20 at the year end.

Income: The income for 2024 (excluding one off legacies) reduced by around £700. We have sadly lost members of the church through bereavement and the subsequent reduction in income also meant less gift aid income. Other income also dropped due to one off events in 2023 such as the electricity refund at £2,865.

Expenditure: Increased by £2,838. This being in addition to the £6,850 increase in 2023. The increase over the last two years is mainly due to changes to presbytery support and therefore the amount required to meet our Giving to Grow commitment, insurance, pulpit supply, organist fees and electricity costs being much higher.

Fabric Account:

Spend from the fabric account was £2,678. Of this £1,554 was donated to pay for refurbishment of the church doors at Irongray Church. Therefore income over expenditure was £2,960. This helped to reduce the impact of transferring £8,000 from this account to the general account to cover day to day expenditure. After transferring the £8,000, the year end balance left in the Fabric account was £18,837.52.

Looking Ahead:

The high expenditure and reduced income for the general account is forecast to continue. The Trustees will be discussing and planning how to manage the situation.

Reserves Policy

It is the Trustees' policy to hold reserves of approximately six months expenditure including designated funds. At the year end the Church held unrestricted cash funds of £84,975. Whilst this represents just over two years expenditure, it should be noted that £59,059 of this relates to a legacy provided in 2024. The increase in general running costs along with reduced income will require funds to be used from reserves to be able to afford running costs in 2025 if legacy funds are excluded.

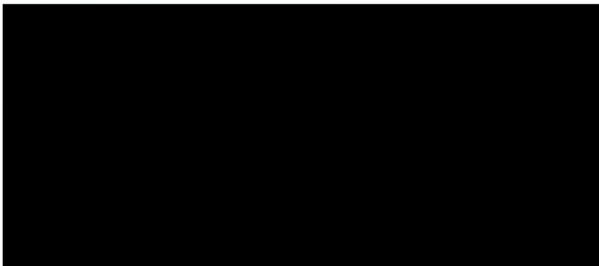



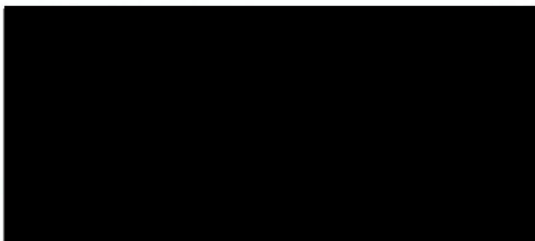
