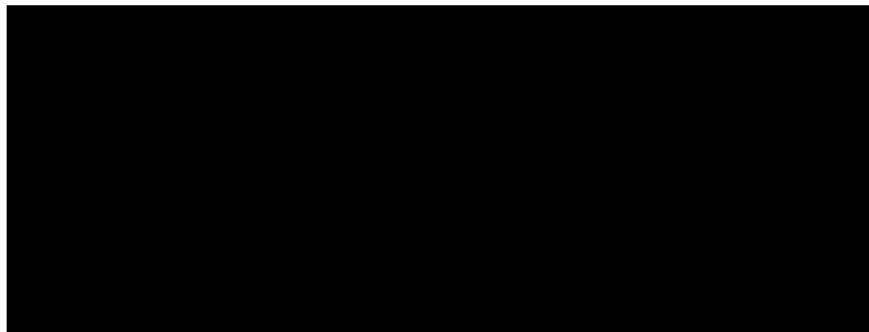

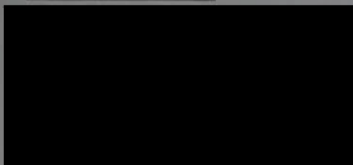

Summary of Main Activities / Achievements

Abbas Rest provides support and aid to orphans, vulnerable children, and elderly residents in the provincial town of Chiringa in Malawi. The charity faced challenges this year due increased costs abroad, as well as money transfer delays and conversion difficulties. The group have finished in a surplus this year, the first in a few years, mainly due to a surge in donations this year. The Trustees are once again to be commended for their continued efforts in supporting those in need.

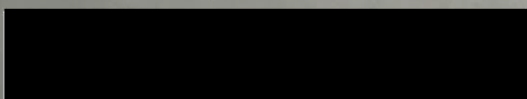
Trustees Remuneration and Expenses

All funds held are unrestricted. The unrestricted funds represent income earned but not yet utilised in supporting charitable activities. It is the policy of Abbas Rest to maintain an operating balance sufficient to cover the typical expenses of 12 months, so that its operations can, if necessary, be closed in a manner which does not cause undue distress to its beneficiaries in Malawi.

**Basis of independent examiner's statement**

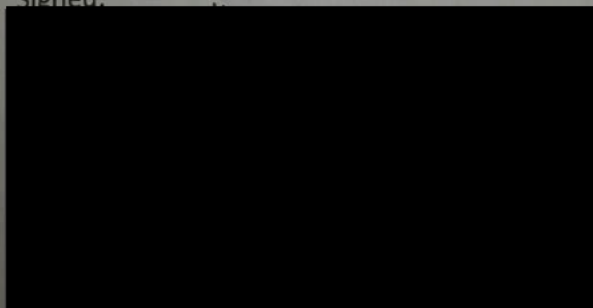
