The membership of Guiding units has remained constant. Our leisure classes continue to attract new members and we continue to promote classes, Guiding and our facilities for community use using our website, social media and local advertising.

APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

We are pleased to report that our income has been sufficient to allow us to meet regular expenditure as well as to continue with both regular maintenance and improvements to our premises. During the year, we have continued to implement our programme of regular maintenance with two emergency lights being replaced as well as the fan and sensor in the gents toilet area. The required safety checks of our boilers, fire and burglar alarm systems, fire extinguishers and portable appliances were carried out.

We still have about 55 members regularly attending our leisure classes and approximately 80 girls coming to Rainbow, Brownie, Guide and Ranger Guide units in the centre.

The continued increases in the cost of electricity and gas throughout the financial year have been concerning, but an increase in regular hall hire, and in the fees charged for our leisure classes has helped to offset this.

We are grateful that the Centre is still viable and continues to be an essential part of life in our village.
