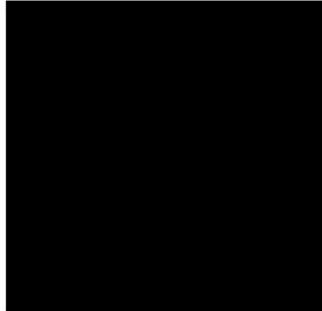

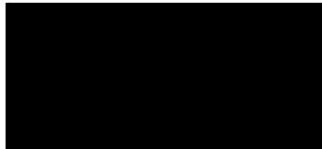

The Trustees submit their Report and Accounts for the period ended 31st March 2025. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the financial statements and comply with the Charity's constitution, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (effective 1 January 2019).

REFERENCE AND ADMINISTRATIVE DETAILS OF THE CHARITY, ITS TRUSTEES AND ADVISORS

Details of the Charity's registration numbers, Trustees, Independent Examiner, bankers, registered and principal office are shown on pages 1 and 2 of the financial statements.

The Trustees are responsible for the operations of the Company and the allocation of funds towards achieving the objectives of the company.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Ardler Village Trust was incorporated as a company limited by guarantee and not having a share capital, and registered as a charity on 27th November 2002. On 9th October 2024 it converted to a Scottish Charitable Incorporated Organisation. Ardler's village Trust has its principal office in Scotland and it will remain in Scotland permanently.

The Ardler Village Trust board is at present made up of 4 Trustees of which are elected by the Ardler Village Trust members at the Ardler Village Trust annual general meeting.

Membership of the Ardler Village Trust is open to all persons of 16 years of age or over, whose principal place of residence is within Ardler (other than employees of the Company, who may not be members). The Ardler Village Trust is operated with one full-time Development Worker.

The Board of Trustees usually met on the third Thursday of every second month. The meetings were held at 6.00 – 8.00pm in the Ardler Complex.

OBJECTIVES AND ACTIVITIES

Ardler Village Trust has been formed with the following objectives under its Memorandum of Association:

to relieve poverty among the residents of the Ardler area of the City of Dundee;

to advance education and provide training in skills of all kinds, particularly such education and/or skills as will assist the residents of Ardler in obtaining employment;

to relieve unemployment for the public benefit in such ways as may be thought fit, including assistance to find employment;

to assist in the relief of ill health and promotion of health education among the residents of Ardler; and

to assist in the prevention of crime and promotion of fire safety within Ardler.

I would like to thank all of the AVT trustees, volunteers and staff for their continued support and enthusiasm. During the reporting period, Ardler Village Trust (AVT) has remained highly engaged within the Ardler community, actively promoting its objectives through a range of initiatives and projects. A key highlight has been the continued success of Café Ardler, which not only provides employment and volunteering opportunities for six local residents but also serves as a vital support hub for hundreds of families and older individuals. By offering affordable access to nutritious meals in a welcoming and safe environment, the café fosters social inclusion and community cohesion. Additionally, it delivers essential information and support services, helping to strengthen local networks and instil a sense of ownership and pride among community members. The charity shop, supported by a dedicated team of volunteers, continues to operate efficiently, ensuring that the shop remains well-stocked and accessible to the community. Alongside the community fridge, these initiatives provide affordable clothing, household goods and food items, while actively promoting environmental sustainability through waste reduction and decreased landfill contributions. In addition, AVT collaborated with the Ardler Complex Local Management Group (LMG) to deliver family-oriented activities during the summer and October school holidays and various work with Ardler Primary, St Fergus Primary and Craigowl Church fostering engagement and social inclusion for families, children and young people. To further strengthen community spirit, AVT also hosted Christmas lunches for residents, creating opportunities for connection and celebration during the festive season.

FUTURE DEVELOPMENTS

Looking ahead, Ardler Village Trust (AVT) aims to build on its success by introducing new initiatives that further strengthen community engagement and sustainability. Key priorities include:

- Expanding Café Ardler Services: Develop additional programs such as social events to promote wellbeing and inclusion.
- Enhancing Volunteer Opportunities: Increase training and support for volunteers to improve skills and create pathways to employment.
- Sustainability Initiatives: Broaden efforts to reduce waste and exploring partnerships for increased surplus food redistribution.
- Community Activities: Organise more family-oriented events throughout the year, including cultural celebrations and seasonal activities, to foster stronger community bonds.
- Digital Engagement: Improve online presence and communication channels to keep residents informed and involved in AVT projects and to actively increase our volunteer and trustee number.

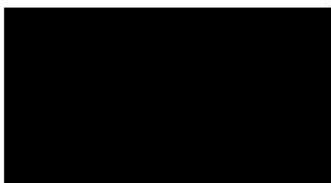

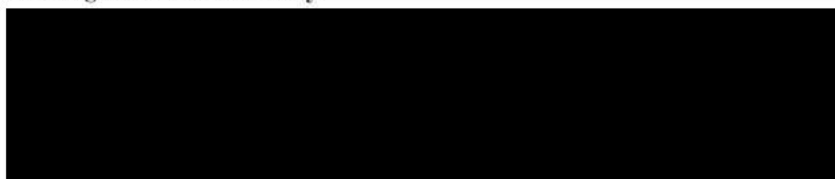

The accounts have been prepared in accordance with applicable accounting standards, the Statement of Recommended Practice, "Accounting and Reporting by Charities", preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS 102), the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

1.2 Incoming Resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

- Voluntary income is received by way of grants, donations and gifts and is included in the Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.
- Investment income is included when receivable.
- Activities for generating funds includes fundraising income which is included when receivable.

1.3 Resources Expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates:

- Costs of generating funds comprise the costs associated with attracting voluntary income and the costs of fundraising activities.
- Charitable activity costs comprise those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.
- Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity.
- All costs are allocated between the expenditure categories of the SOFA on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly, others are apportioned on an appropriate usage basis.

1.4 Fund Accounting

- Unrestricted funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity.
- Designated funds are unrestricted funds earmarked by the Trustees for a particular purpose.
- Restricted funds are subjected to restrictions on their expenditure imposed by the donor or through the terms of an appeal.

The income of the Charity is exempt from charge to tax in accordance with the provision of the Income and Corporation Taxes Act 1988. The Charity is not registered for VAT and accordingly any such tax suffered is included in the expenditure concerned.

3. CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

In the application of the Charity's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future period
