The Trustees of Art Moves hereby submit their report and accounts for the year ended 31 March 2026.

### **Structure, Governance and Management**

Art Moves is a charity, registered in Scotland and is governed by its constitution. The trustees are responsible for the administration and direction of the charity.

### **Recruitment and appointment of Trustees**

All of the charity's trustees are appointed or reappointed by the members at the annual general meeting. New trustees are recruited on an ad hoc basis, as and when required. There are no formal induction or training procedures in place.

### **Charitable Purposes**

The aims and objectives of Art Moves is to promote the welfare of people with disabilities living in Angus by encouraging participation in a range of arts activities and cultural events, developing skills, and enabling community involvement so as to improve their conditions of life.

### **Activities and Achievements**

In preparing our activities for the year, we emphasized the need to balance the immediate needs of the charity's beneficiaries to be able to preserve funds.

The main activities are as follows:

- The Summer Drama Project
- Fundraising

These activities benefit adults with disabilities by developing self-confidence and social skills. These projects offer new experiences, promotes an increased sense of wellbeing, and enables community involvement.

#### **Summer Drama Project**

The project provided twenty-one actors the opportunity to collaborate with the award-winning writer/director Mr J Binnie and Mr R Mitchel photographer/designer.

A devised performance of William Shakespeare's play As you like it was chosen for the project. The performance was open to the public and the audience invited to support us through a bucket collection at the entrance.

#### Cutting Edge Theatre Project

The Opportunity to have Art Moves Summer drama workshop included in a mapping resource across Scotland to help people with learning disabilities and additional support needs to accessible drama and classes near them.

The Edinburgh based company Cutting Edge have confirmed they have all the necessary information and will provide further updated once their resource goes live.

#### Fundraising

Art Moves enable people with learning disabilities to sit on the committee as this is an effective way to ensure our services are user-led.

#### Trustee Remuneration and Expenses

#### Financial Review

Our main source of funds this year has been activity fees. We use general funds to subsidise activity costs and do not hold a reserves policy. This was reviewed on march 27<sup>th</sup> and no change made

Much of our income is applied to the Drama with the main costs incurred being, professional fees and venue hire.

The charity is actively seeking funds to further increase the level of unrestricted reserves which is currently sat at £4,163.

#### Future Plans

The coming year will see a continued emphasis on the Summer Drama Project and other activities to build on the positive impact of taking part in the Arts.

#### Governance

The charity's governing document was reviewed, and the statement of charitable purposes were found fit for purpose.
