The Annual Business Meeting for 2024 was in Lossiemouth and is hosted by different Battalions on a rotational basis throughout the Area – officers of the 1st Buckie are regular attendees.

Fund Raising

We are very active as a Boys' Brigade Company. Coffee Mornings, Pancake Teas, participating in the local Buckie Kracker, various lucky squares, lego competitions to name but a few of our events.

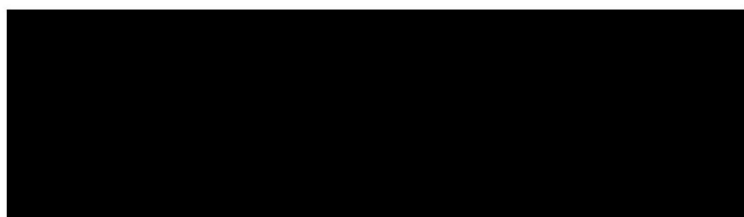

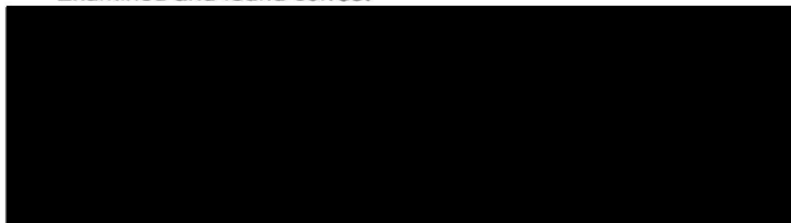

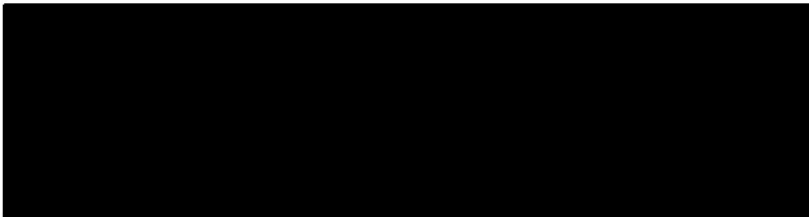
