The above unit is an unincorporated association. It has no written constitution, but operates in accordance with the rules and regulations of the Scouting Association.

Its trustees are the volunteer adult leaders appointed as Leaders and Assistant Leaders.

The charity's aim is to deliver a programme of informal education in accordance with the ethos and principles of the Scouting Association. During the above period the charity provided this programme to around 35 young people in the area.

The charity's main income is subscription income.

The charity aims to hold sufficient cash funds to meet all expenditure due and anticipated during a 2 month period.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 (the Charities Act) and that an independent examination is needed.

- Examine the accounts under section 145 of the Charities Act,

Basis of independent examiner's statement

My examination was carried out in accordance with the general Directions given by the Charity Commission. An examination includes a review of the 4 accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items of disclosures in the accounts and seeking explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair' view, and the report is limited to those matters set out in the statement below.

Independent examiner's statement
