Achievements and performance

Summary of the main achievements of the charity during the financial period

The total funds raised during the year, from fund raising activities, was £18k. The most significant fund raising event was the summer fayre.

Uniform sales contributed to a net loss for the year of £1k.

A routine annual donation of £5k was provided to the Head Teacher, which allows the Head Teacher to invest in school facilities and special events for the pupils, in addition to other charitable activities totalling £12k.

In summary, the charity operated at net loss of £0.2k for the year.

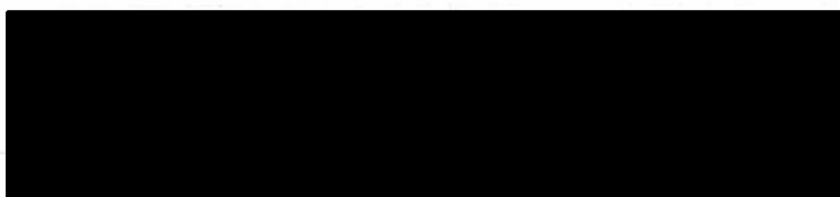
