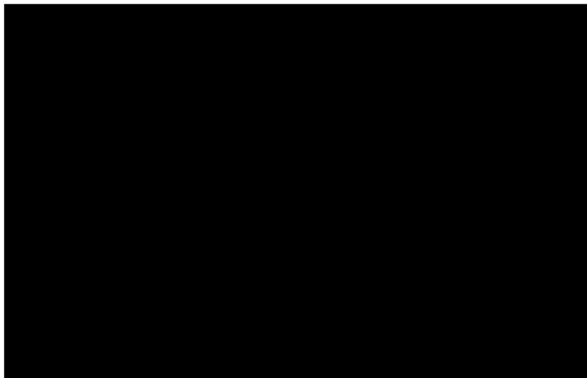

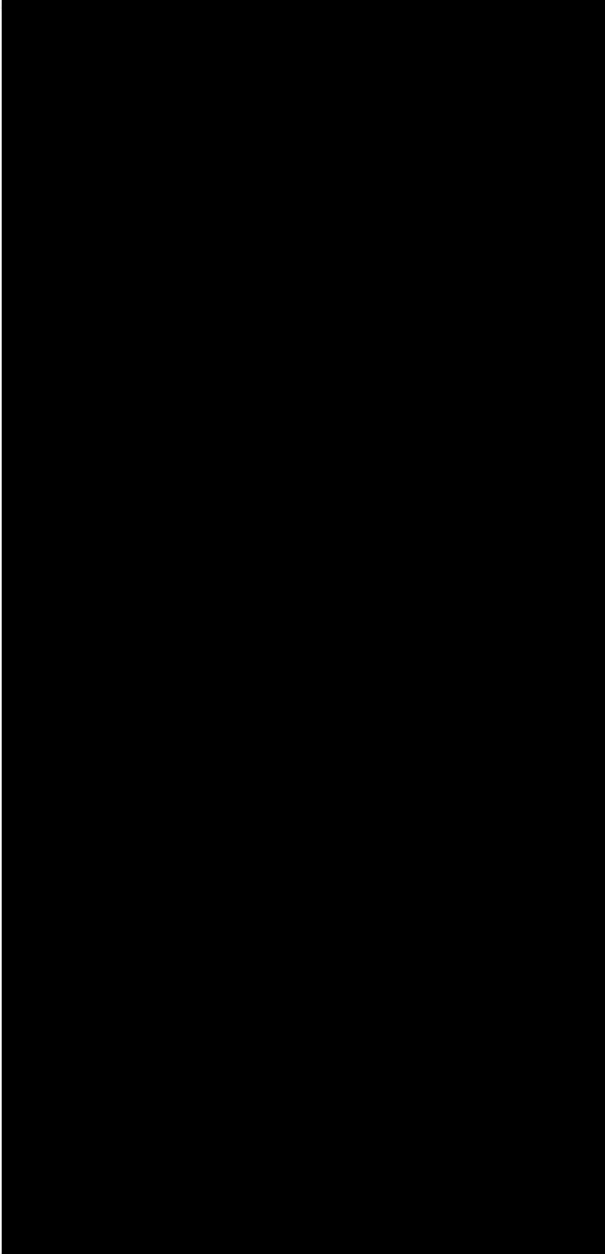

## **Charity Trustees**

The elders of the Kirk Session are the trustees of the charity. No new elders were ordained in 2023.



## **Objectives and activities**

The Church of Scotland is Trinitarian in doctrine, reformed in tradition and Presbyterian in policy. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

The congregation of Birsay, Harray and Sandwick meets to worship in the Milestone Community Church, a modern facility for the use of our congregation and the wider community. Morning worship takes place there at 11am every Sunday.

The congregation supports their young people in various ways. Messy Kirk restarted in 2022 on a termly basis with some of the youth leaders going into Dounby Primary School at the invitation of the head teacher and taking 'mini Messy Church' in all the classes. All these groups are run by dedicated parents and friends, for whose efforts we are very grateful.

The Boys Brigade, although not an integral part of the congregation, is sponsored and supervised by it. They are led by two officers and the minister as chaplain. Regular meetings have been held during the year, with Anchors, Junior and Company sections being provided for.

A faithful group of people go to Smiddybrae House, the local residential care home in Dounby, at 2.30pm on three Sundays a month, to lead worship for their more elderly neighbours.

Our Guild has continued monthly meetings in 2023.

We supported Fair Trade Fortnight and Christian Aid.

We promote Fairtrade in having goods for sale on the premises, holding Fairtrade events and encouraging our bakers to use Fairtrade ingredients.

Sunday worship in church has continued all through 2023. Monday morning prayer meetings continue and a weekly open coffee social gathering has replaced Friday prayer meetings.

## **Structure, governance and management**

### Type of governing document

The Church is administered in accordance with the terms of the Deed of Constitution.

### Trustee recruitment and appointment

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

### Organisational Structure

The Kirk Session meets as required, and is responsible for all matters within the church. Matters are delegated to four teams, comprising elders and other members of the church, and responsible for particular areas of service – Property, Fundraising and Finance, Mission and Pastoral Care.

## **Achievements and performance**

This is the first full year with new ministers Rev Kerr Wintersgill and Rev Moira Taylor-Wintersgill.

Milestone Community Church has continued to serve the community in the last year through various ways.

### Church

Explicitly Faith based...

We have a Sunday morning service each week. On the first Sunday of every month we offer informal communion after the service, and this is well attended. On the second Sunday we have Café style church, with a live praise band that has been formed through this (known as West Mainland Praise Band) We hold services in the local care home on the first and third Sundays of each month at 3pm. We hold a Stillness service every Wednesday afternoon. We hosted an Alpha course in the Spring.

## Social...

We provide a free soup lunch each week from October to March (Thursday Soup Lunch) which is popular and well attended. We also host a soup lunch on the fourth Sunday of every month directly after the service, which is also very popular. We have tea, coffee & fancies after each service and on café church Sundays, tea and coffee before the service too.

The Toast Stop in Dounby Primary is still popular and has been extended to two mornings a week (Wednesdays and Fridays). In addition we are regularly involved in taking individual class, groups of classes and whole school for messy church and assemblies. We assist with sports day, judge the annual talent competition, have sponsored annual awards for Burns Day and an annual end of year citizenship award which is voted on by school staff. We attend PTA meetings and help with various activities and provide chaplaincy to the school.

In 2023 and this year we took a tent at the Dounby Show and it gave folk a chance to chat to the ministers. We offered free popcorn, opportunities to make prayer requests and free crafts (stone painting & friendship bracelets) Our ministers have been involved in various community events such as the Harray Seniors dinner, St Magnus Day Service, Tree lighting, Dounby Shopping night, Speech making practice with young farmers, remembrance day events etc.

In April we hosted an icon painting workshop with a visiting tutor from the Edinburgh School of Iconography and hope to do another course next year.

## **Financial review**

2023 has seen a reduction with Donations and Fundraising income and an increase with some costs and this has resulted in a deficit of £1,388 for 2023. Church finances remain reasonably healthy with over six months operating costs in reserve.

## **Future plans**

We will continue to serve the local community through worship and pastoral care, offering comfortable and reasonably priced rooms for local groups. We will also continue to help and support the local community with a focus on support for children, families and those who are more vulnerable through age, poverty or mental health.

## **Additional information**

We are enormously grateful to everyone who supports the church in many varied ways. From serving tea to visiting with flowers, leading craft with children to playing the organ, giving regular donations to leaving a legacy there are many ways to be involved and to ensure the involvement of others for generations to come and all of it is very much appreciated.

**Independent Examiner's Report to the Trustees of Birsay, Harray & Sandwick Church**

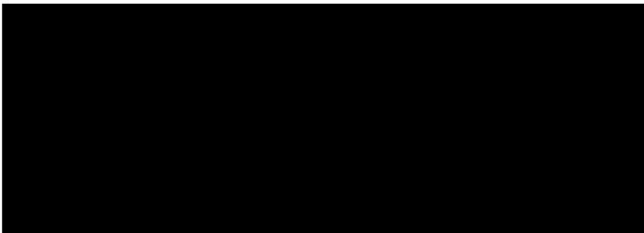
**Basis of independent examiner's statement**
