The Trustee Board have pleasure in presenting their report together with the financial statements and the independent examiner's report for the year ended 15th August 2025

### Name and Address

The group name is the 21st Craigmaldon (South Queensferry) Scout Group and it may be contacted at The Nelson Scout Hall, Port Edgar Marina, South Queensferry, Edinburgh, EH30 9SQ.

### Constitution and Purpose

The Scout Group is constituted in terms of the rules of the Scout Association, which is a charitable body incorporated by Royal Charter. The Scout Group is a registered Scottish charity – No: SC035688.

The purpose of the Scout Association is to promote the development of young people in achieving their full physical, intellectual, social and spiritual potential, as individuals, as responsible citizens and as members of their local, national and international communities. The method of achieving the aim of the Association is by providing an enjoyable and attractive scheme of progressive training based on the Scout Promise and Law and guided by adult leadership.

Unless stated above, the Trustee Board members are also the Trustees of the charity. Trustees are recruited and appointed in accordance with the Policy, Organisation and Rules (POR) of the Scout Association. They are responsible for the general control and management of the Scout Group.

## **Activities During the Year**

### **Scouting Activities**

During 2024/25 our member numbers remain strong this year with around 160 young people being recorded across our Squirrel, Beaver, Cub, Scout, Explorer and Young Leaders.

Appointments have been made in key leadership roles - two Group Lead Group Volunteer running the role as a job share, and Squirrel section leader - with work to recruit and stabilise the sections with the help of our team leaders and team members for each section.

Demand for scouting remains high in our community, showing the Group's ongoing popularity. However, challenges remain, and a principal one is recruiting volunteers to key sections, with the current gaps in the Scouts section.

During the year the sections have enjoyed many activities and events including hikes, watersports, crafts and camps as well as playing an active role in our community by participating in litter picks, environmental conservation, Remembrance Sunday events and the Ferry Fair Parade.

### **Letting of the Scout Hall**

The rent generated from hall letting to third parties is our dominant source of income for the Group, covering the costs of operating our premises and enabling us keep the required level of member subscriptions low. During the year regular hall lets continued to take place as well as one off lets, mainly for children's birthday parties but have also included corporate, training and charity events and a Scottish National Blood Transfusion Service donation session. Whilst demand for use of the hall remains high more volunteers would help to make opening/closing the hall for these lets easier.

### **Running the Scout Hall**

The Scout Hall remains the Group's greatest physical asset, but also the Group's largest potential liability in terms of maintenance and ongoing development.

## **Financial Review**

### **Financial position**

This year we've continued to invest in new equipment and have carried out important repairs to our building – both of which are reflected in our financial results. For the year to 15 August 2025, the Group reports a deficit of £11,725 (compared to a deficit of £4,319 in 2023–2024). As a result, our general funds have decreased during the year with primary drivers:

- purchase of new tents for use by all sections
- building repairs,
- the cost of a full year of professional cleaning services, which we only introduced partway through the previous year.

### **Finance Operating Policy**

The Group's Finance Operating Policy was applied throughout the year. This fully complies with Scout District guidelines and sets out the financial practices those involved with the Group's finances must follow to safeguard the Group's financial resources.

### **Fundraising**

Fundraising continues to help to keep term fees affordable and enables us to enrich the programme enjoyed by all the respective Sections. Activities during the year included the selling of compost, which the Group finds is a great way of maintaining linkage with the local community.

### **Reserves Policy**

Given the significance of the Groups assets, including a large hall, the policy of the Trustees is to maintain at least £20,000 in surplus funds to cover unexpected maintenance and repair requirements to the Hall. This is so that future Trustees will have a firm platform to work from and to help ensure sustainability of the Scout movement in South Queensferry.

## Plans and looking ahead

The Group Development Plan (GDP) is subject to ongoing review by the Group's Trustees. This, together with on-going financial budgeting and reporting, provides a well organised structure for prudent and targeted governance and financial decision making.

We are actively searching for Group Chair, following the resignation of former Chair Esa Aldegheri.

Our main priorities for the coming year:

- secure sufficient volunteer resource for the Group so we can continue to deliver the Scouting experience to young people locally,
- renewables project (subject to successful grant applications) so we can use more sustainable energy sources and reduce our ongoing costs.

In addition, we will continue to focus on maintaining and developing our Scout Hall.

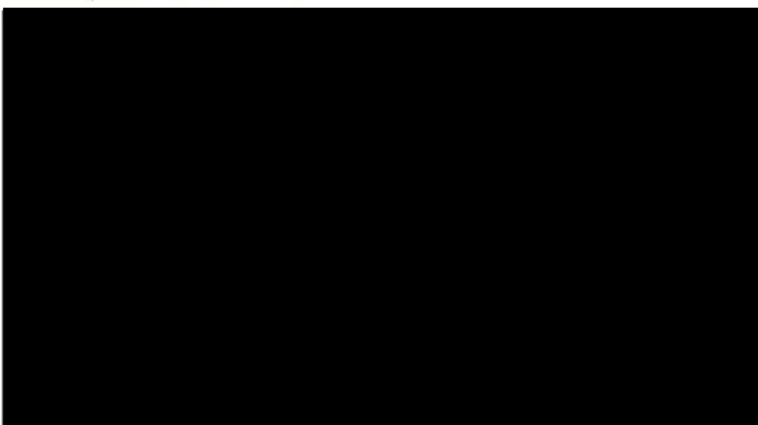

## **Activities During the Year**

### **Scouting Activities**

During 2023/24 our member numbers remain strong this year with around 160 young people being recorded across our Squirrel, Beaver, Cub, Scout, Explorer and Young Leaders.

A principal challenge is the need for more volunteers in key leadership roles - Group Lead Volunteer and leaders for Scouts and Squirrels - and the resulting lack of capacity for existing young members to move up to the next section . Demand however, for places within the Scout Group, remains high with waiting lists in operation. While we have had some success in attracting new volunteers this year, further volunteer resource continues to be sought.

Administration & Communications and Finance & Fundraising teams have been created, enabling work that may have fallen to a single person to be shared .

### **Letting of the Scout Hall**

The rent generated from hall letting to third parties is our dominant source of income for the Group, covering the costs of operating our premises and enabling us keep the required level of member subscriptions low. During the year regular hall lets continued to take place as well as one off lets, mainly for children's birthday parties but have also included corporate, training and charity events and a Scottish National Blood Transfusion Service donation session. Whilst demand for use of the hall remains high more volunteers would help to make opening/closing the hall for these lets easier.

### **Running the Scout Hall**

The Scout Hall remains the Group's greatest physical asset, but also the Group's largest potential liability in terms of maintenance and ongoing development.

## **Financial Review**

### **Financial position**

The Group's bank balance remains in a healthy position. The receipts and payments account shows a deficit for the year of £4,319, (2023 Surplus: £6,703 ), which decreased our general funds. The primary drivers behind the deficit were:

- Reduction in hall lets income
- No Gift Aid Claim due to an issue with submission to HMRC

### **Finance Operating Policy**

The Group's Finance Operating Policy was applied throughout the year. This fully complies with Scout District guidelines and sets out the financial practices those involved with the Group's finances must follow to safeguard the Group's financial resources.

### **Fundraising**

Fundraising continues to help to keep term fees affordable and enables us to enrich the programme enjoyed by all the respective Sections. Activities during the year included the selling of compost, which the Group finds is a great way of maintaining linkage with the local community.

### **Reserves Policy**

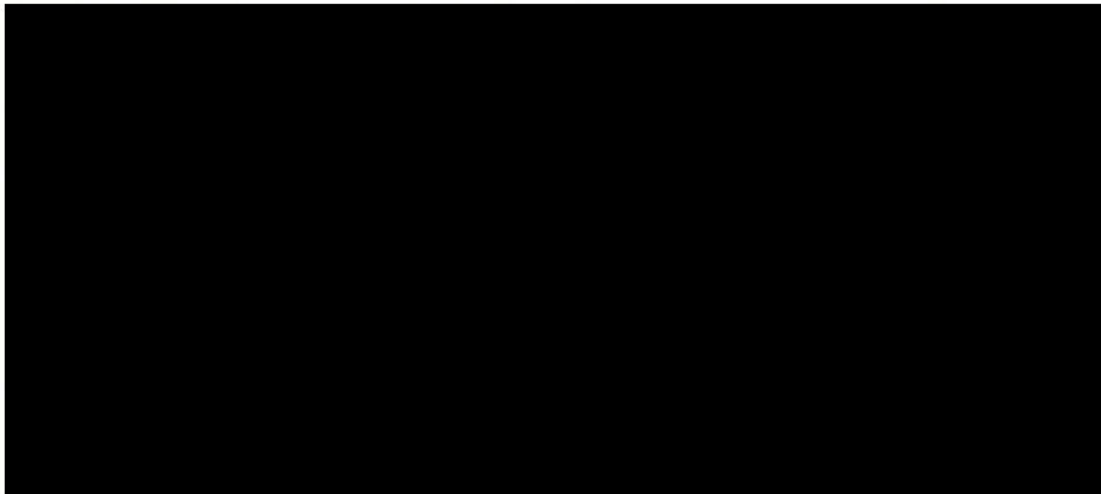

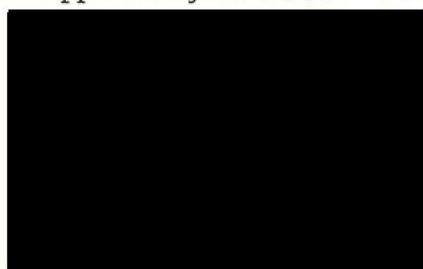
