Governing Document

The Band is a charitable unincorporated association and the purposes and administration arrangements are set out in our constitution.

Charitable Purpose

Pitlochry & Blair Atholl Pipe Band was formed in 2004 by a group of local musicians intent on developing the Pipe Band concept to cover all Celtic music. The main objective is to promote, advance and encourage bagpipe playing and drumming and to promote the traditions of playing pipe band music generally by way of public performances and other related activities.

Activities and achievements

The band continues to grow, and is accomplishing its primary objective of catering for all ages and abilities and the promotion of Celtic and traditional music. New band members have performed at various local events and for local social groups together with more established members. New members are supported and encouraged to take part in competitions to gain experience and enjoy the camaraderie of fellow players. We will soon be taking part in the local Remembrance Day Parade, with pride. We also regularly play at Blair Atholl Castle and invited to attend and play at Avenches Tattoo in August 2024

We continue to receive donations from the local community and from further afield. Our fundraising efforts continued with our stalls at local community events.

Trustee remuneration and expenses

The Trustees did not receive any remuneration or expenses during the year.

Reserves

The Band holds unrestricted funds of £13,741.28 and £2,840.11 reserved funds. We feel this we feel is sufficient to carry forward our plans to continue to promote and teach traditional pipe band and Celtic music. We have already had some very successful fundraising events and hope to secure future funding by way of donations and grant funding.
