3rd Forfar Scout Group is an independent charity which is affiliated with the Scout Association; however, it is not our parent body. We follow the constitution as set out in the policy, organisation and rules of the Scout Association (with Scottish variation). Our purposes are to actively engage and support young people in their personal development, empowering them to make a positive contribution to society.

Recruitment and Appointment of Trustees:

All the Group Trustees are appointed by the Committee and parents at our AGM held in Spring each year.

Activities & Achievements

Now having completed our first financial year in our own building we can start calculating the realtime cost of having our own hall. The building still needs some maintenance but on a much smaller scale. All of our sections are enjoying their programme with all apart from Squirrels enjoying the freedom of Nights away experiences with a huge percentage of take up. We have been present within the local community with lots of fundraising and community awareness events including at the local Gala Day, Tesco Blue tokens scheme, the local Inner Wheel, supporting the local OAP hall, at Remembrance day Poppy selling and parade, a fundraising Gin night with a local producer and assorted local visits across the sections. All sections have had recipients of the top awards as well as many activity, participation, staged and challenge badges. The focus of the Trustees has been steered towards the governance of the Group which is heading in the right direction. We now have a Treasurer and full Trustee Board. Our Leadership team has a variety of characters who give a broad spectrum of opinions to the young people with us and enables them to find their own opinions. Our numbers continue to remain stable with young people joining as older ones age out.

Trustee and Remuneration Expenses

The Trustees did not receive any remuneration or expenses during the year.

Reserves Policy

As a result of the surplus from all accounts of £6189 the group holds general unrestricted funds of £10827 and the Beavers, Cubs and Scouts hold designated unrestricted funds of £1009. Subscription levels will be reviewed at the A.G.M.

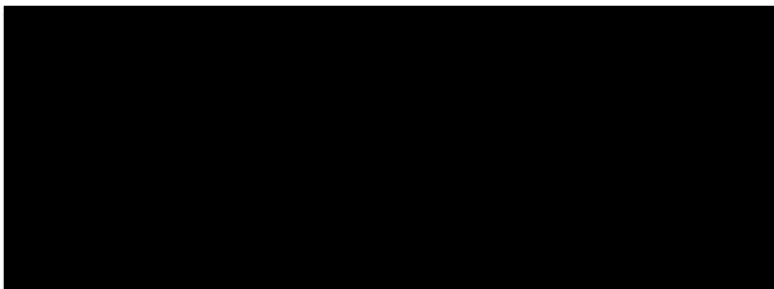

Independent Examiner's Report to the Trustees of the 3rd Forfar Scout Group

I report on the financial statements of the 3rd Forfar Scout Group ("the Group") for the year ended 31 March 2025

Respective responsibilities of Trustees and Examiner

The Group's Trustees are responsible for the preparation of the accounts in accordance with the Charities and Trustee Investment (Scotland) Act 2005 ("the Act") and the Charities Accounts (Scotland) Regulations 2006 ("the Regulations"). The Group's Trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's Statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the Group and a comparison of the accounts presented with the those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent Examiner's Statement
