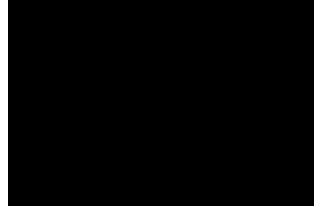

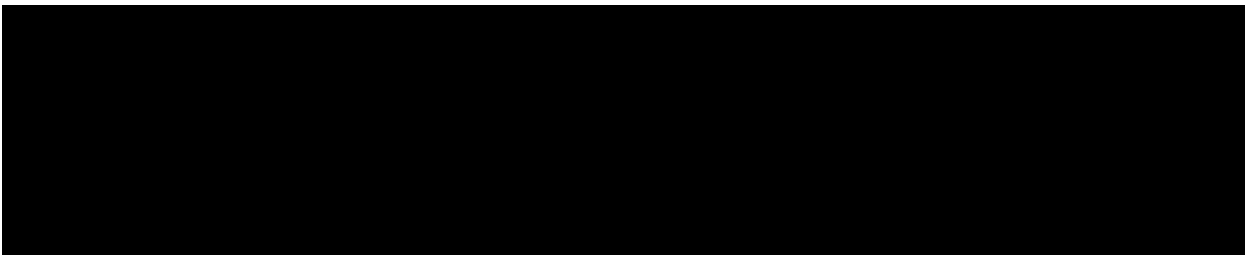

TRUSTEES ANNUAL REPORT FOR YEAR ENDED 31 AUGUST 2025

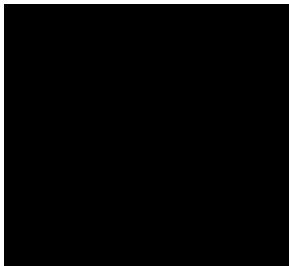

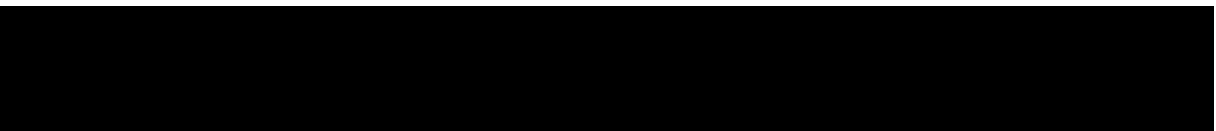

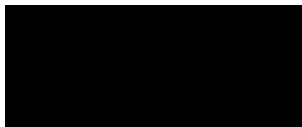

Independent Examiners Report

I report on the accounts of the 1st Elgin Beaver Cub Scouts for the year ended 31st

August 2025 as detailed.

Respective Responsibilities of trustee and examiner.

The Charities trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Account (Scotland) Regulations 2006. The Charity Trustees consider that the audit requirement of Regulation 10(10(d) of the accounts does not apply. It is my responsibility to examine the accounts as required under section 44(1) of the Act and to state whether particular matters have come to my attention.

Basis of Independent examiners statement.

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland Regulations 2006).
