Activities: 'It makes grants, donations, loans, gifts or pensions to individuals', 'It carries out activities or services itself'

Purposes: 'the prevention or relief of poverty', 'the advancement of education', 'the advancement of religion', 'the advancement of health', 'the advancement of citizenship or community development', 'the advancement of the arts, heritage, culture or science', 'the advancement of public participation in sport', 'the provision of recreational facilities, or the organisation of recreational activities, with the object of improving the conditions of life for the persons for whom the facilities or activities are primarily intended', 'the advancement of human rights, conflict resolution or reconciliation', 'the promotion of religious or racial harmony', 'the promotion of equality and diversity', 'the advancement of environmental protection or improvement', 'the relief of those in need by reason of age, ill-health, disability, financial hardship or other disadvantage', 'the advancement of animal welfare', 'any other purpose that may reasonably be regarded as analogous to any of the preceding purposes'

What the charity does: To charity maintains Inverness Masjid in the Highlands.

Beneficiaries: 'Children or young people', 'Older People', 'People with disabilities or health problems', 'People with a particular ethnic or racial origin'

Objectives: (a) To promote the Islamic faith, in particular by the building or otherwise acquiring property for, maintenance and operation of a Masjid in particular but not exclusively for the benefit of the Muslim community in Inverness and the rest of Highland. (b) To provide facilities in the interests of social welfare for recreation and other leisure time occupation with the object of improving the conditions of life of the above Muslim community. (c) To advance education and in particular Islamic education. (d) To relieve poverty. (e) To promote good race relations. (f) To do such other things pursuant to the above as are charitable in law and in all cases for the public benefit.
