**Activities:** 'It carries out activities or services itself'

**Purposes:** 'the prevention or relief of poverty', 'the advancement of education', 'the advancement of health', 'the advancement of citizenship or community development', 'the advancement of public participation in sport', 'the provision of recreational facilities, or the organisation of recreational activities, with the object of improving the conditions of life for the persons for whom the facilities or activities are primarily intended', 'the promotion of religious or racial harmony', 'the promotion of equality and diversity', 'the advancement of environmental protection or improvement', 'any other purpose that may reasonably be regarded as analogous to any of the preceding purposes'

**What the charity does:** Improving the quality of life for our community, with a particular focus on empowering young people (ages 11-25) who face significant barriers or limited opportunities.

**Beneficiaries:** 'Children or young people', 'Older People', 'People with disabilities or health problems', 'People with a particular ethnic or racial origin', 'Other defined groups', 'No specific group, or for the benefit of the community', 'Other charities or voluntary bodies'

**Objectives:** (1) To relieve poverty and distress particularly among young people (aged 11 to 25) and adults and families in necessitous circumstances, resident in the Greater Wishaw area (ML2) (with an initial focus on those resident in the ML2 8\*\* postal code area but extending over time to those resident in such other adjacent areas as the directors may consider appropriate (the areas served by the company from time to time being referred to as 'the Operating Area')). (2) To advance education of those aged 12 - 25 and encourage lifelong learning, particularly among people resident in the Operating Area. (3) To promote training in skills of all kinds, particularly such skills as will assist young people resident in the Operating Area in obtaining paid

employment. (4) To safeguard, preserve and protect and further the health of the public (and particularly those resident in the Operating Area) through the increase of public knowledge and awareness of issues relating to health and healthy living. (5) To relieve the needs of those people resident in the Operating Area who suffer from mental and/or physical illness, disability or impairment. (6) To promote, establish, operate and/or support other schemes and projects of a charitable nature for the benefit of the community within the Operating Area.
