From early years support to parental wellbeing and community connection, we've remained a safe and trusted space. ? Over 600 families engaged with our services throughout the year ? More than 1,000 healthy meals provided through our community lunch programme ? Increased support through our Holiday Programmes, with support from funders we have been able to offer additional opportunities including an Easter Programme, Halloween parties and breakfast support during our Summer programme ? 25 parents received one-to-one support, including help with housing, benefits and emotional wellbeing through our family support and counselling service ? Expansion of our Dads' Work, engaging fathers within our service through targeted stay and play sessions and informal meetups
