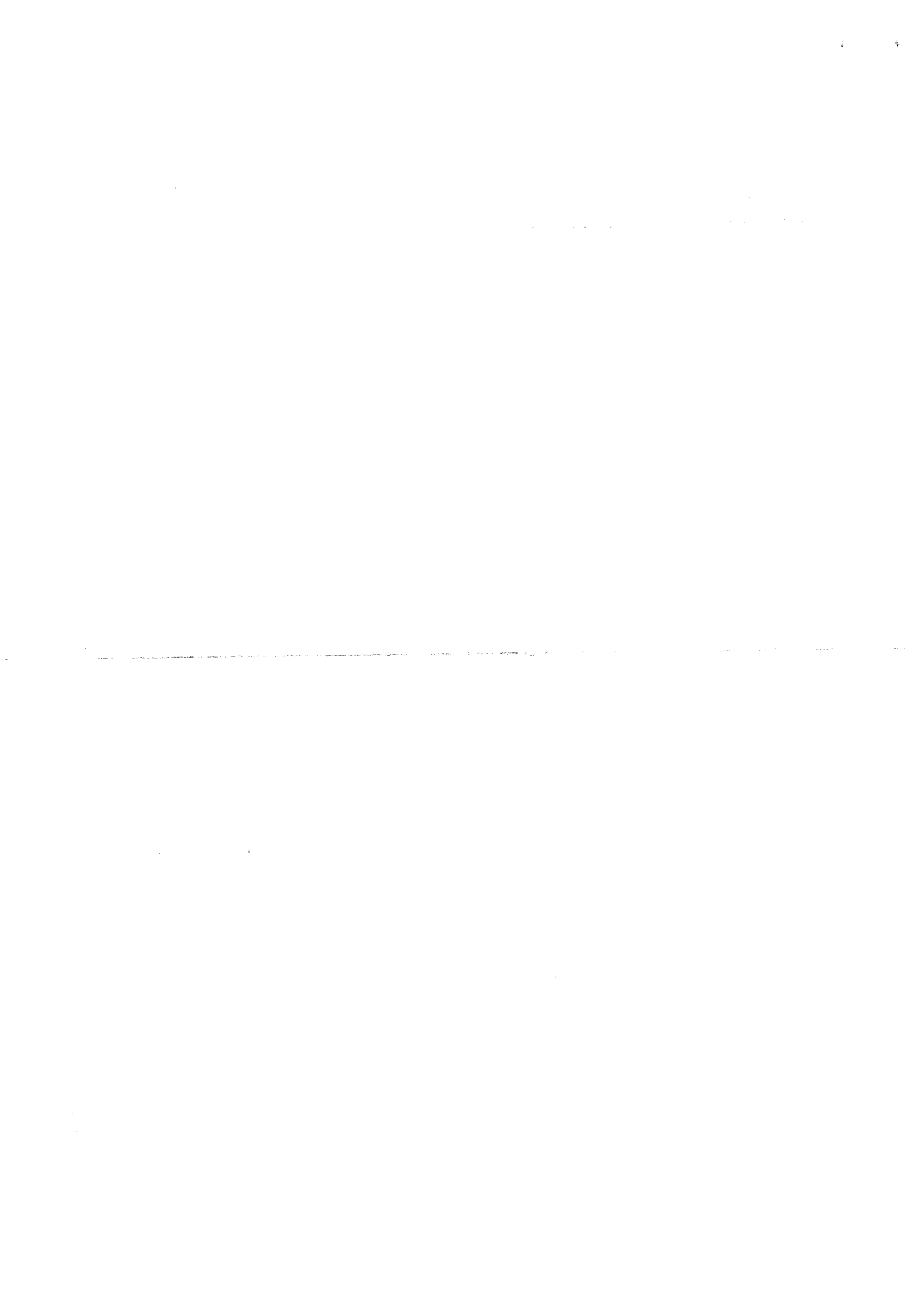

- 4) Displaying God's word on M77 Motorway.

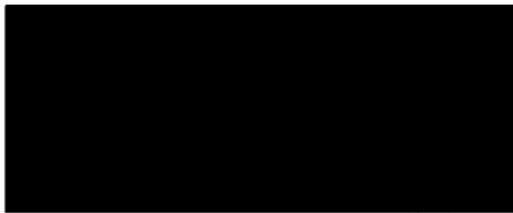
All literature supplied and distributed by the Charity is provided free of charge.

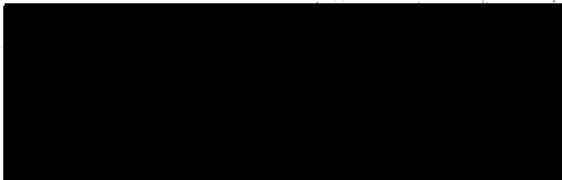

**INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES' OF HIGHWAYS & BYWAYS – SEED SOW TRUST**

**Respective responsibilities of trustees' and examiner**

**Basis of independent examiner's statement**


