What the charity does: Our aims are to engage in the public worship of God, and to enjoy fellowship together, by meeting regularly at least 3 times a week. We reach out with the gospel of the Lord Jesus Christ by preaching and personal testimony, and undertaking in the town outdoor preaching occasionally, and the provision of a monthly Christian Literature table. Additionally we provide a weekly Drop-in, and a monthly children's meeting.

Objectives: The Congregation aims to maintain the public worship of God and to foster Christian fellowship. to evangelise the local area by proclaiming the gospel of Jesus Christ, to exercise pastoral care and practical compassion for those in need. to uphold and further the interests of the Free Church of Scotland. and to participate in the worldwide promotion of Christian fellowship and the advancement of the Christian faith. All the business and proceedings of the Congregation shall be conducted in accordance with the constitution of the Free Church of Scotland, under the supervision of the Presbytery of the bounds, and in terms of the Acts, deliverances or directions of the General Assembly of the Free Church of Scotland.

Aims and Affiliation

Dumfries Free Church of Scotland is a congregation of the Free Church of Scotland working towards the common aims set out below. It is a Presbyterian church adhering in its worship and doctrine to the position of the Church of Scotland at the Reformation. The Free Church of Scotland has an explanatory document which explains the origins of the Church and which gives the historical background to the Church coming into being in 1843 and lists documents in which is embodied the constitution of the Church. The document is available on request from the Free Church of Scotland, 15 North Bank St., The Mound, Edinburgh, EH1 2LS.

The Free Church of Scotland currently has over 100 congregations in Scotland, as well as one in London and four in North America, and sister Churches founded by mission work in India, Peru and South Africa. The Church also has a seminary in Edinburgh for the training of ministers and other Christian workers. The principal activity of the Church is the conduct of public worship and associated matters in the context of local congregations.

Dating from 1843 but with its roots in the Reformation, the Free Church of Scotland owes its distinctive title to its historical struggle to remain 'free' from state interference in its internal affairs. It has close and active relations with many other Reformed churches of Jesus Christ throughout the world and stands firmly in the tradition which accepts the Bible in its entirety as the Word of God and, therefore, derives its

forms of teaching, worship, ministry and government from it. The main emphasis of our worship is the preaching of the gospel - the good news of a free and sovereign salvation through Jesus Christ alone.

The Church building and the manse are the property of the congregation and are held in trust by locally elected congregational trustees under the Church's Model Trust Deed.

Trustees and Office Bearers

The congregation is governed and administered by elected office bearers (all volunteers) and its Minister. The Kirk Session, being the Minister and elected elders, has responsibility for spiritual oversight, while the Deacons' Court, composed of Kirk Session members plus elected deacons, oversees financial and property matters. Under Charity Law, the Deacons' Court are deemed to be the Trustees of the congregation as those with responsibility for day to day management and control. This is distinct from the role of congregational trustees who are responsible only for holding property in trust. The members of the Deacons' Court who served during the year were as follows:

Appointment of Charity Trustees

The Kirk Session exercises its discretion in determining the most appropriate method of electing new Trustees (Elders and Deacons). Any election process must involve the communicant membership of the congregation. There is no fixed term for Trusteeship. Prior to their appointment, new Trustees would have served the Church for some time in various roles and would be familiar with the Church's values, its aims and objectives as well as its day-to-day operations. As part of their induction programme, new Trustees are required to understand their statutory responsibilities and the responsibilities of their office as elder or deacon. The Trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide assurance against fraud and error.

Activities

During the year, the congregation met for public worship and carried out various activities in pursuit of the above stated aims. The congregation continued its commitment to support the national Free Church of Scotland both spiritually and financially. The following matters are highlighted:

In relation to **congregational activities**:

- [Redacted] of Dowanvale Free Church, withdrew as assessor Elder, just after the year end, suffering from ill-health.
- The congregation is thankful for preachers, many of whom travel long distances, to lead the worship on the Lord's Day, and for spiritual benefit received from their ministry.
- During the year a child of members was baptised. We are encouraged by the number of young children in the congregation.
- We continue to welcome a number of Iranian asylum seekers to the services. In addition to the Sunday services, they attend Bible studies for them during the week.

- The regular Wednesday *Drop-in* continues, with the support of a Bethany Christian Trust supervisor.
- With some of the children now being older, it was necessary to change the format of *First Steps* (a carers and toddlers group) to *Seeds & Saplings* (ages 8 and under), with more structure and Bible teaching. It meets on the second Saturday morning of each month; it is advertised in *Facebook*, and it would be encouraging if local people attended.
- A Carol Service was held in the Lower Hall in December. Refreshments were served afterwards.
- The practice of enjoying together the occasional Congregational Meal, following the morning service, continues.
- With the practical help of the Open Air Mission, open air preaching on the High Street was undertaken on a few occasions during the year. Additionally, a monthly Christian Literature table started in November.
- Detailed Reports were submitted to the Presbytery in December as a prelude to a Presbytery Oversight Visit (POV) in 2025. The response of Presbytery will replace any response from the Presbytery Strategy Committee, following a meeting in February 2022.
- We are thankful for Mann Judd Gordon Ltd, of Stornoway undertaking the responsibility of the Independent Examiner.

In relation to **congregational funding**:

- Giving to the General Fund increased a little in 2024, the majority of the increase being accounted for by external donors; there is continued thankfulness for this encouragement and help.
- The minimum remittance required from the Mission Board is the Administration Levy which varies according to income levels.
- The Deacons' Court has established two funds to make provision for potential future ministry, namely, a Designated Ministry Fund and additionally a Restricted Ministry Fund for income restricted by donors for this purpose.
- In January 2025 roof repairs at the manse, involving the removal of two chimneys, were undertaken at a cost of £3,228. An estimate of £6,758 has been accepted for roof repairs at the church building.

Reserves and Results for the Year

There was a surplus of £8,001 on the General Fund. This was transferred to the Unrestricted Designated Ministry Fund. The year ended with balances on the Fabric Fund and General Fund being £28,730 and £16,098, respectively. The Unrestricted Designated Ministry Fund and Restricted Ministry Fund had a combined balance of £46,928. The trustees are satisfied with the level of reserves retained by the charity, being in total £92,044 (2023: £72,006).

Report of the Independent Examiner to the Trustees for the year ended 31 December 2024

I report on the accounts of the church for the year ended 31 December 2024 which are set out on pages 6 to 11.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

1. Accounting Policies

(i) Accounting Convention

The financial statements have been prepared under the historical cost convention, and in accordance with the Charities Accounts (Scotland) Regulations 2006.

(ii) Basis of financial statements

The financial statements have been prepared on a receipts and payments basis.

(iii) Fixed Assets

Details of the assets held are shown in note 11 to the accounts. No depreciation has been applied as depreciation is a non-cash item and therefore should not be included in the receipts and payments account.

(iv) VAT

The congregation is not registered for VAT and expenditure includes VAT where applicable.

(v) Explanation of Funds

Unrestricted funds comprise income received for the objects of the church without further specified purpose and are available as general funds.

Designated funds represent unrestricted funds which have been earmarked by the Trustees for particular purposes. In addition to the Fabric Fund, the Deacons' Court established recently a Ministry Fund.

Restricted funds comprise income which has been received for the objects of the church and specified for a restricted purpose within these objects by the donor.

2. Gift Aid Small Donations (GASD) Scheme

HMRC launched this scheme from 6 April 2013, whereby tax is claimed back on small cash donations (with a maximum of £8,000 from 6 April 2016) which are not covered by gift aid declarations, provided certain conditions are met.

3. Investment income

£152 was received from the Dalzell Bequest, administered by the Church of Scotland; it is money designated for the Sustentation Fund, and therefore is classified under Restricted Funds.

Interest earned on the Term Deposit (see Note 8) is allocated to the Fabric Fund.

4. Remittance to Central Funds

The remittance due in 2024 relates to the Administration Levy of £1,560.

5. Transactions with Trustees

There were no transactions with the Trustees, apart from reimbursing expenditure incurred on behalf of the congregation. Trustee Indemnity Insurance is included in the premium charged by the Insurance Co, but no longer identifies it separately. During the year £576 expenses were paid to the Interim Moderator (2023 - nil).

6. Mission

Mission expenses total £1,320, of which £571 relates to the weekly Drop-in.

Explanation of Funds

The General Fund encompasses all income and expenditure relating to the primary focus of the activities of the charity, other than those for which income is restricted.

The Ministry Fund was established by the Deacons' Court on 19th January 2023 to set aside funds in the hope that within a couple of years it may be possible to call a minister or arrange Resident Supply for an initial period of three years.

The Fabric Fund represents the money set aside by the Deacons' Court for the fabric of the buildings and the repayment of loans in respect of property. Rental income and interest received are credited to the Fund.

Explanation of Funds

The Manse Fund relates to the property. The present manse was purchased from the proceeds of the sale of the former manse (£120,000) and a donation. Consequently, the manse fund is made up of a Designated (Unrestricted) Fund of £120,000 and a Restricted Fund of £70,000.

The Dalzell Bequest Fund represents money given towards the sustentation fund of the congregation. The main Dalzell Bequest fund is held by the Church of Scotland which administers it to its various constituent parts.

The Benevolent Fund is for the purpose of providing financial assistance at the discretion of the Deacons' Court. It is funded mainly from retiring offerings following partaking of the Lord's Supper.

The Restricted Ministry Fund was established by the Deacons' Court on 30th March 2023 for income restricted by the donor for the purposes of funding Ministry, including Resident Supply and weekly Supply expenditure.

11. Fixed Assets

The congregation owns the church building at 20 George Street and the manse at 48 Averill Crescent DG2 7RY, and the title deeds are held in terms of the model trust deed of the Free Church of Scotland. The sale, and use of proceeds of sale, requires the authorisation of the General Assembly of the Free Church of Scotland.

The manse was purchased in October 2011 at a price of £190,000. The church building has not been valued in view of the limited market available and is not included in the Statement of Balances. The church building is insured for £1,798,126 and the manse for £340,702.
