The Directors have the pleasure in presenting their Report and Financial Statements for the year to 31 March 2026.

The Directors present their annual report with the financial statements of the company for the financial Year ended 31 March 2026. These have been prepared in accordance with the Statement of Recommended Practice - 'Accounting and Reporting by Charities' issued in 2005.

The principal activity is to advance the education of the public in the history and traditions of Castle Craig by the preservation, protection, restoration and maintenance for the benefit of the public of the said Castle Craig in Ross Shire, Black Isle.

Recruitment and Appointment of Directors

The Directors of the company are also charity trustees for the purpose of charity law and under the company's Articles are known as members of the Board of Directors. Directors are appointed at an AGM or any other time as considered appropriate by the Board of Directors.

Directors are recruited to a skills based specification to ensure that the Board has a good balance of the skills and experience relevant to the work of the organisation. A list of Directors is to be found below.

Risk Management

The Board of Directors has conducted a review of the major risks to which the organisation is exposed. A risk register has been established and is updated at least annually. Where appropriate, systems or procedures have been established to mitigate the risks the charity faces.

Organisation Structure

The Directors meet as required. These meetings are attended by at least a quorum of the Directors.

Objectives and Activities

The objectives of the company are to advance the education of the public in the history of traditions of Castle Craig.

The Directors have studied a survey report from Archaeology Services of Castle Craig but are yet to consult an architect.

During the year the company has received donations which have been deposited in the company's bank account.

to the trustees of The Black Isle Castle Craig Foundation

I report on the financial statements for the year ended 31 March 2026 which are set out on pages 1 to 4.

Respective responsibilities of the Trustees and Independent Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustees Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. Basis of Independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006.
