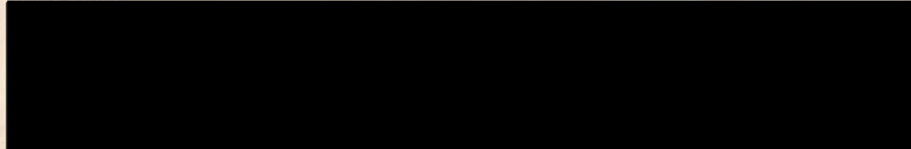

Constitution & Purpose

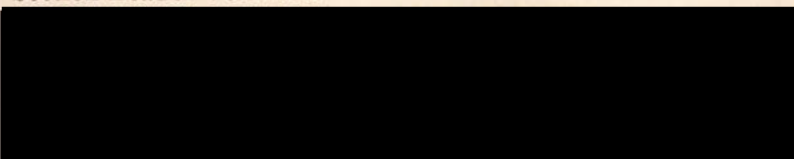
The Scout Group is constituted in terms of The Scout Association, which is a charitable body incorporated by Royal Charter.

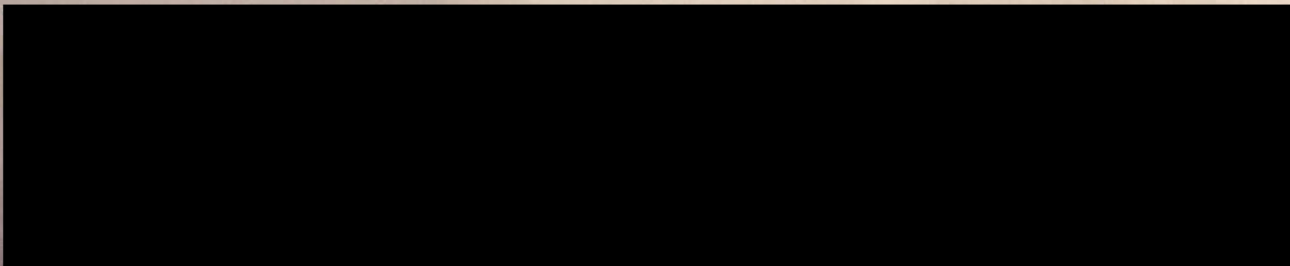


Trustees are recruited and appointed in accordance with the Policy, Organisation & Rules of the Scout Association.

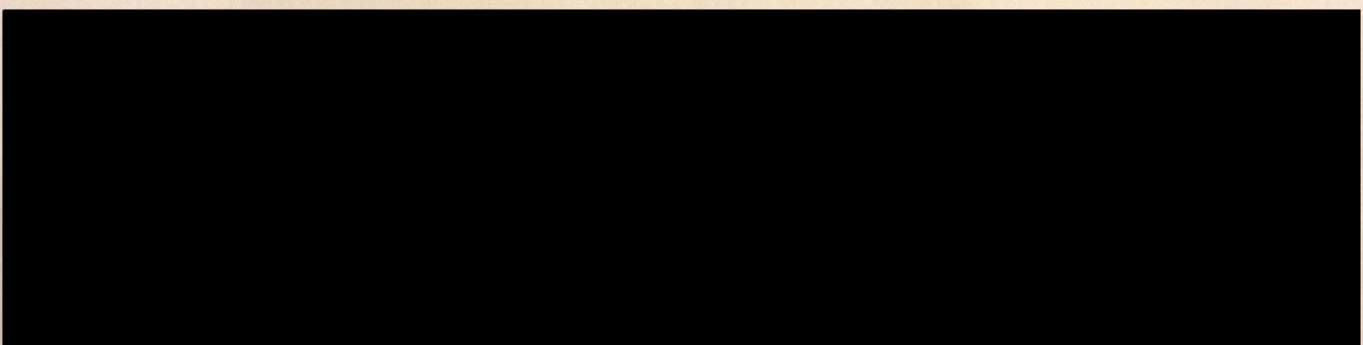

Independent Examiner's Report to the Trustees of the 12th Fife (East Neuk) Scout Group

I report on the financial statements of the 12th Fife (East Neuk) Scout Group (the Group) for the year ended 31 March 2025 which are set out in pages 1 to 6.

Respective responsibilities of Trustees and Examiner

The Group's Trustees are responsible for the preparation of the accounts in accordance with the Charities and Trustee Investment (Scotland) Act 2005 ("the act") and the Charities Accounts (Scotland) Regulations 2006 ("the regulations"). The Group's Trustees consider that the audit requirements of Regulation 10(1)d does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's Statement

My examination is carried out in accordance with the Regulations. An examination includes a review of the accounting records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given in the accounts.

Independent Examiner's Statement
