Objectives: (i) to relieve the needs carers of individuals residents in West Dunbartonshire who are suffering from any form of mental and /or physical disability illness or impairment which may include age associated problems) and those for whom they provide the care (ii) to advance the education, increase the health and welfare and relieve the poverty and distress of carers within West Dunbartonshire area and elsewhere ('the Area of Benefit'), carers being defined for the purpose as being those persons who care in a voluntary capacity for any individual suffering from any form of mental and / or physical disability, illness or impairment (iii) to promote and/or provide training to carers and others in skills associated with the care of and for meeting the needs of or providing support to people resident in the Area of Benefit and suffering from any form of mental and/or physical disability illness or impairment.
