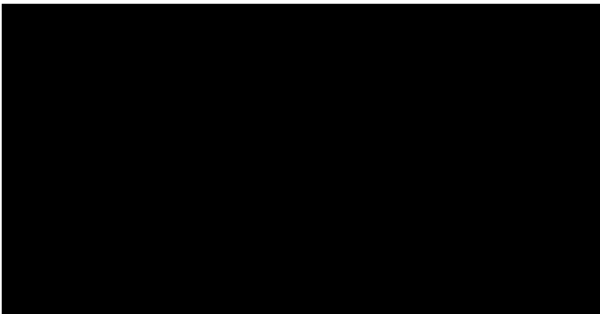
The District Executive have the pleasure of presenting their report together with the financial statements and the independent examiners report for the year ended 31 March 2025.

**Constitution and Purpose**

Renfrewshire District Scout Council is constituted in terms of the Rules of the Scout Association, which is a charitable body incorporated by Royal Charter. The District Scout Council is a registered Scottish Charity - OSCR No SCO39363.

The purpose of the Scout Association is to promote the development of young people in achieving their full physical, intellectual, social and spiritual potential, as individuals, as responsible citizens and as members of their local, national and international communities. The method of achieving the aims of the Association is by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and guided by adult leadership.

**Trustees**



Trustees are recruited and appointed in accordance with the Policies, Organisation and Rules ('POR') of the Scout Association.

**Review of Activities**

The District currently consists of 13 Scout Groups providing scouting opportunities to a total of 882 young people during the year, although this total is down from 922 last year.

Groups have been extremely active since the last AGM with camps, visits, hikes and community projects. This showcases the depth and quality of the volunteers in Renfrewshire, who continue to facilitate these experiences for the young people in the District.

**Reserves Policy**

The Trustees believe that between £5,000 and £10,000 is an appropriate level of reserves in order to cover timing differences between receipts and payments, particularly regarding District events, and allow unexpected expenditure to be incurred in support of Scout Groups and wider Scouting activity within the District.
