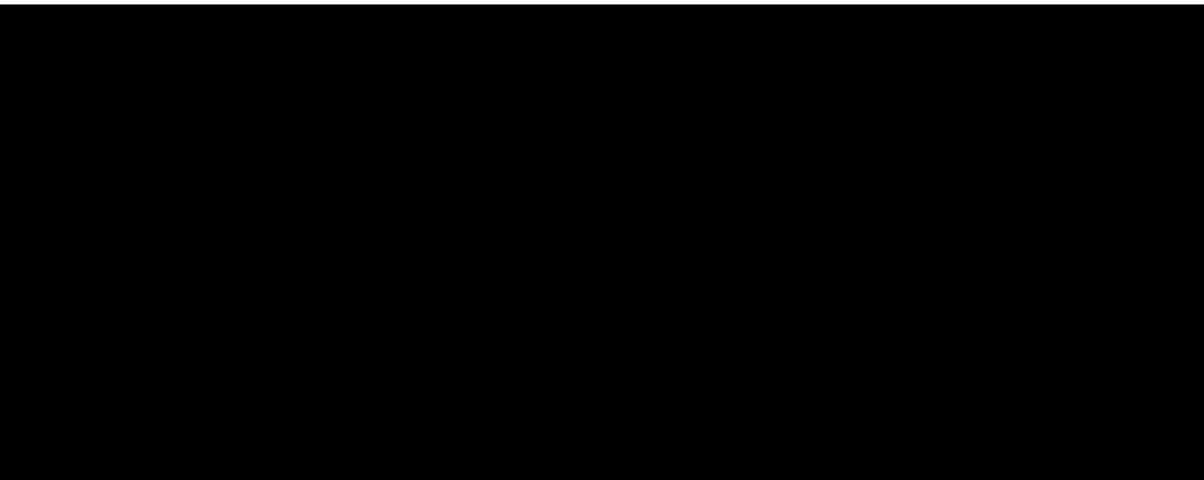

Structure Governance & Management

The 1st Torphins Scout Group is an unincorporated Scottish charity and is governed by the Scout Association Policy Organisation Rules.

Appointment of Trustees

All of the Scout Group's Trustees are appointed or reappointed at our Annual General Meeting, which is normally held between April and June each year. The Trustees received no remuneration during the year.

Objectives & Activities

Charitable Purposes

The purpose of the 1st Torphins Scout Group is to promote Scouting in the village of Torphins.

Activities and Achievements

During the year we continued to run the 1st Torphins Beavers, Cubs and Scouts. At the close of 2024 there were 23 Scouts, 26 Cubs, 23 Beavers and 8 Explorers involved with these four sections.

Activities were many and varied both inside and out, with guests attending the Beaver evening meetings. Cubs had a camp and many other evening activities. The Scouts had several camps, including a national activity camp and a winter camp, a Burns' Night, a night hill walk with chips afterward and lots of evening activities. The Explorers were also active with bothy nights, camps and a long weekend sailing on the west coast.

Cubs raised £236.39 from their 2024 Christmas Post, which the Cubs decided to keep for Group funds. The Scout Group also held one fund raiser, a ceilidh in December 2024 raising £2,430.

Financial Review

Our previous main source of income, fees, has been supplemented with one fundraising event during 2024, plus the addition of donations and grants (i.e. from Leaders' employers, trusts, etc). The donations and grants increased significantly during 2024 to £5,950, allowing capital expenditure (and Group administration costs), primarily on camping equipment, to increase from £1,819 to £4,776. Fees were retained at the same level as they had been during 2023.

The restricted fund stands at £1,042 made up of £504 from the Torphins Community Building Project (for the purchase of a gas storage cage, oil drums and construction poles) as £214 was spent on pioneering poles, £0 from Bread of Life (for the purchase of new tents) as £1,815 was spent on camping equipment, and £538 for Garden Project (to be spent on the garden behind Learney Hall).

Gift Aid for 2020, 2021, 2022, 2023 and 2024 are all outstanding. A request was made to HMRC at the start of the year for login details to submit these claims but no details were received after 5 months, so needs to be followed up before the end of 2025.

Total income for the year was £31,535, with total expenditure of £19,402 making a net surplus the year of £12,133. Of this, fundraising and administration accounts combined account for a surplus of £3,196, the Scout Section accounts for a surplus of £3,397, Cubs a surplus of £2,298, Beavers a surplus of £1,447 and Explorers a surplus of £1,796. It should be noted that the Explorer surplus is primarily due to an issue with the GoCardless account not being verified and therefore not paying the income collected by this means into the bank account prior to 2024. This was

subsequently resolved with all amounts being received into the bank account early in 2024. The 2023 deficit for the Explorers was £1,062.

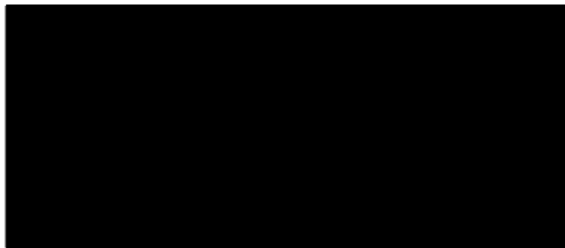
Costs such as hall hire, OSM subscriptions and GoCardless fees are now accounted for as a Group as opposed to being assigned to individual Sections for ease of accounting.

Reserves Policy

Closing reserves on funds have increased this year to £21,498. These funds are required to cover the working capital for the group, for purchase and maintenance of equipment, leader training and to fund activities not covered by annual subscriptions, although due to significant grants, fundraising and delayed fees paid by the Explorer and not received into the bank account, this amount is likely higher than actually required.

It is the intention of the committee that each section continues to charge fees which are sufficient to cover its own running costs. At the AGM in June 2025, it was agreed that each Sections could run at a deficit going forward, only charging additional fees for camps not general activities.

Independent Examiner's Report For the Year Ended 31 December 2024

Independent Examiner's Report to the Trustees of 1st Torphins Scout Group

I report on the financial statements of the charity for the year ended 31 December 2024, which are set out on pages 5 to 9.

Respective Responsibilities of Trustees and Examiner

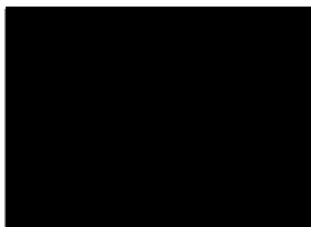
Basis of Independent Examiner's Statement

NOTES TO THE ACCOUNTS

1 Basis of Accounting

These accounts were prepared on a Receipts and Payments basis.

2 Nature and Purpose of Funds

Unrestricted funds are those that may be used at the discretion of the trustees in furtherance of the objects of the charity. The trustees maintain a single unrestricted fund for the day-to-day running of the charity.

Restricted funds may only be used for specific purposes. Restrictions arise when specified by the donor or when funds are raised for specific purposes.

3 Related Party Transactions

During the year payments totalling £6,672.74 were made to eight different Scout leaders, with £2,1071.83 of which was related to the two ceilidh fundraising events, and £1,822.97 related to camping equipment capital. These represented reimbursement of expenses incurred by them as Leaders. No remuneration was paid to Leaders or Trustees.
