The Gift Shop trades within a building within Quarrymill Woodland Park, Isla Road, Perth. It operates 7 days trading from March to the end of October annually. The Committee are all volunteers who share the responsibility of sourcing, pricing and displaying the stock.

Beneficiaries: 'People with disabilities or health problems','Other charities or voluntary bodies'

Objectives: The objects of the Association shall be to advance the health of cancer patients within Perth and Kinross and to provide relief and support for them through such cancer projects that may be determined by the Association in General Meeting or by the Management Committee

Financial Report for the Year 2024

2024 has proved to be another success story for the Gift Shop. Never did the Committee think at the start of the season we would surpass 2023 figures. But with care and attention to the buying and displaying the stock I am pleased to announce that the Gift Shop 'has done it again'. Many thanks to the continued support from the public, volunteers, staff and Committee members in helping to raise funds for Cornhill Support Group Perth.

The turnover for 2024 was £66,519.08 which is approximately an increase of 1.75% on 2023. An incredible result and well done to all involved.

Comments on the Accounts

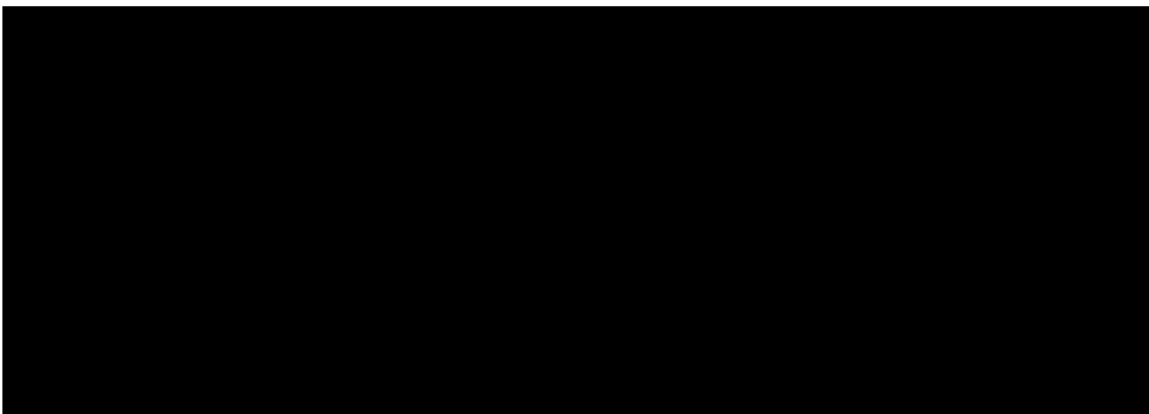
As agreed at the AGM in February 2024 the surplus to be donated to Cornhill Support Group from the trading activities in the Gift Shop was £26,108.59.

I donated £15,000.00 in April 2024 and the balance of the agreed amount, of £11,108.59 in August 2024.

The surplus for 2024 is £29,468.32 which requires to be approved at the AGM for donation to Cornhill Macmillan Support Group.

The Final Result

As Treasurer, my intention after approval at the AGM in February 2025 is to donate £15,000.00 in April 2025 to Cornhill Support Group and the remaining balance of £14,468.32 to be donated as and when the Gift Shop is generating sufficient funds to cover the 2025 expenditure.

Independent Examiner's Statement

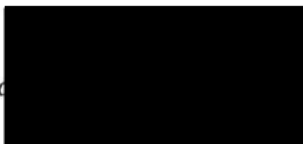
In the course of my examination, no matter has come to my attention.

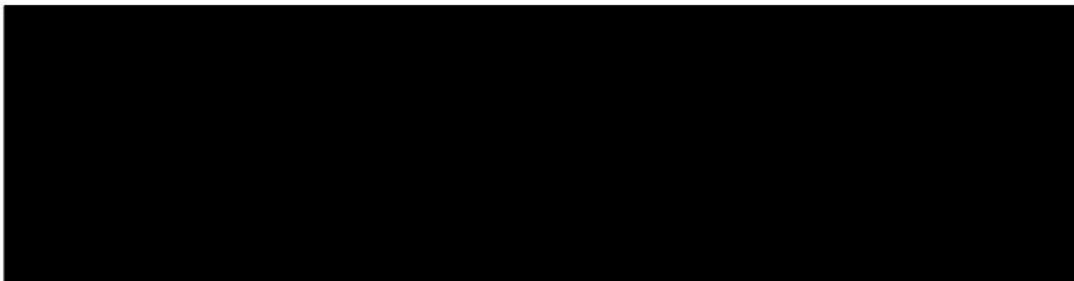
to prepare accounts which accord with the accounting records and comply with Regulation 9 of the 2006 Accounts Regulations have not been met , or
