The Company's Purposes are: To provide or advance the accessibility of recreational facilities, and/or organising recreational activities, which will be available to members of the Community and public at large with the object of improving the conditions

of life of the Community. Advancement of citizenship or Community development, including rural or urban regeneration. Further to provide direct financial support any inhabitant or inhabitants of the Community (1) entering into tertiary education, and/or (2) for small community development type projects.
