Type of governing document The Trust was set up by William Ellis Nicholson and was recognised as a Scottish Charity with effect from 13th May, 2009. The Trust is administered in accordance with the terms of the Trust Deed.

Trustee recruitment and appointment The trustees were those appointed on the establishment of the trust. Appointment and removal is in accordance with the Trust Deed. The power to appoint new trustees is vested in the Settlor during his lifetime.

Training of Trustees The Trustees' Solicitors, Turcan Connell, have appraised the Trustees of the implementation of the Charity and Trustee Investment (Scotland) Act 2005 in particular with reference to their duties and responsibilities as Charity Trustees, charity law in general and other areas of the law as necessary.

Reserves Policy:

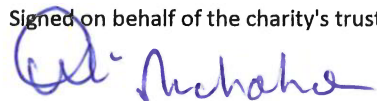
It is intended that the Trustees will distribute the income of the Trust in the form of Grants or Donations.
