Activities

What the charity does: Logan's Fund is a Scottish based children's cancer charity which aims to provide anything that will give a cause for optimism or an alternative focus away from hospital and beyond the treatment they are going through for any child and their family affected by cancer. Logan's Sunny Days is a holiday caravan situated in Lossiemouth available for any family affected by childhood cancer. It is open all year round, offering week-long stays. We also arrange and fund as much of the week's activities as possible. Always a Rainbow is our sponsorship programme where we fund things that children and their siblings may have missed out on during treatment such as swimming lessons, horse-riding, dancing and music classes. We offer grants to buy puppies and sponsor parents, mainly by funding driving lessons. We work in partnership with Hammond Drysuits to provide specialist Hickman Line Dry Suits, which allow children to learn to swim or continue swimming after having a Hickman line fitted.

Beneficiaries: 'People with disabilities or health problems'

Objectives: The advancement of Health including the prevention and relief of sickness and human suffering. the advancement of education. through raising funds to provide neuroblastoma sufferers and their families with treatment and support and to further medical research for the condition of neuroblastoma. In addition to publicise and educate the public of this condition.

Charitable purposes

To support families affected by childhood cancer throughout Scotland while a broader sense raising awareness of childhood cancer.
The charity's primary aim is to provide families who have a child undergoing treatment both short- and long-term support that encourages a positive outlook and focus for the family. To achieve this the charity runs key programmes as well as the possibility of very specific gifting awards.

Summary of the main activities in relation to these objects

Logan's Sunny Days is the charity's respite caravan facility which offers key holiday and family time together in a relaxed setting. The caravan is a have families with a child receiving treatment, for post treatment and for bereaved families. As well as providing a vacation facility the charity also arranges and funds all activities for the family during their stay. The facility is available all year-round.

Always a Rainbow is the charity's sponsorship programme giving primarily children the opportunity to take part in the activities that treatment may have prevented them doing both due to the sacrifices made and also financial restrictions. The programme also recognises the sacrifices siblings make and will sponsor them also as well as parents. This is a long term programme that encourages development, learning new skills, building confidence, creating friendships and having fun.

Our gifting programme now focuses on two main specific 'items' of support. The first being our Puppy programme where we grant families the opportunity to bring a dog into their lives. We have an upper limit of granting 6 per year in order to protect our operating funds. This programme has proved a unique life changing initiative.

The charity also provides specialist drysuits to children receiving treatment to allow them to swim and play in the sea and other water based activities. We work in partnership with a company who pioneered these suits. They are the only company in the United Kingdom making such a suit and we are one of only two charities we are aware of who grant these suits.

APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

The continued success of Logan’s Sunny Days which has proved a real haven for families who have enjoyed using the facility. The facility is used by around 25 to 30 families in the year. Because we organise and fund a family’s week of activities while on their respite break this eases the financial burden as well as giving them a memorable week of experiences they may otherwise not have done. Always a Rainbow has continued to grow year on year with new interest being generated each week and new participants starting their own specific activities on a regular basis. We believe this to be a quite unique programme that will continue to grow and grow. Children as well as parents throughout Scotland are now participating on the programme and reaping the benefits. We granted 6 puppies throughout the year resulting in life changing help. The charity’s name has continued to grow and the volume of work and levels of support we offer families increased despite the charity being run entirely by volunteers.

Financial review

Brief statement of the charity’s policy on reserves

Our reserves are very modest and are only at a level that would allow us to run for a period of less than a year if our income streams stopped with immediate effect. 2024/25 was the first financial year since the start of the covid pandemic in 2020 that our income was greater than our output. All previous years in this timeframe were a large deficit. Due to changes we made to refocus our spending and support this has stopped the charity finances from being massively in danger and had this financial year followed its predecessors it would have been catastrophic for Logan’s Fund.

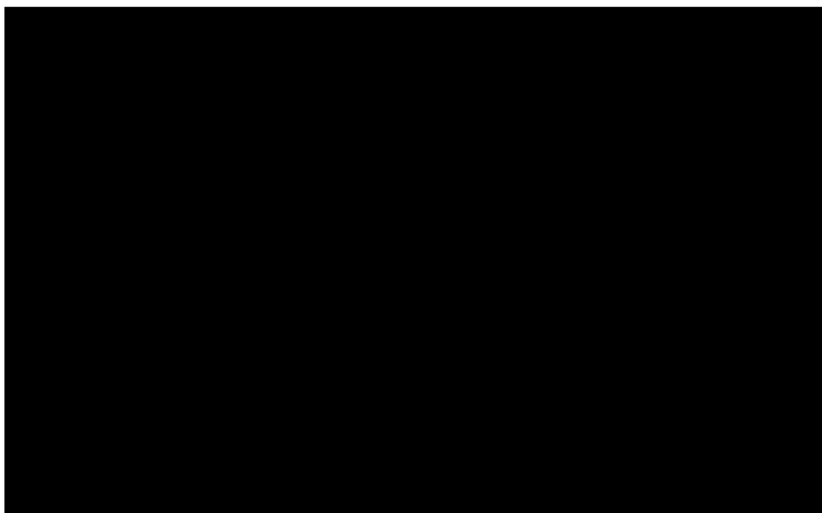
