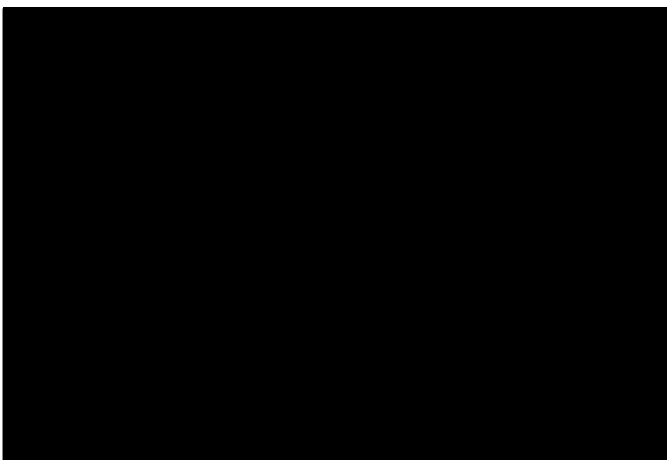

3.Charitable Objects:

4.Activities 2021/2022.

There was no activity this year as the focus of the local authority is on the conversion of Perth`s City Hall.A locally based arts/cinema initiative in Crieff is progressing and there are some signs of museum/heritage interest in Blairgowrie.Local authority budgets are extremely restrained and existing arts & Museum services seem likely to be reduced.It remains to be seen whether this will afford opportunities for independent arts initiatives in the coming years.

5.Financial Review.

As in previous years the Trust had no income or expenditure or a bank account.Accordingly the Trust has no Annual Accounts or Independent Examiner.
